aircraft in the air, it also poses an increased risk of something bad happening. Here's where it is so important to get your head out of the cockpit and be diligent in looking for traffic.

Don't rely on or being focused on the IPad

2021 Air Academy Camp Scholarship Applications

The application for the 2021 Air Academy Camp at Oshkosh is now available! The application is attached to this newsletter (See page 11) and also

available on the chapter website at https://chapters.eaa.org/eaa846. Any interested applicants need to be between 16 and 18 years old at the time of the camp. The camp should take place beginning Tuesday, July 20, ending Wednesday, July 28, 2021. The applicant needs to provide two reference letters and an essay attached to the application. The deadline for submission is Friday, December 4, 2020.

The Chapter has sent nine recipients to Oshkosh since 2002 and we have never had a disappointed camper. The kids spend time learning how to weld, work with fiberglass, rivet together a sparkplug holder, and creating wood ribs. They spend time in ground school, fly simulators, and are given rides in various aircraft. The Air Academy Lodge normally accommodates approximately fifty kids in this particular camp. Each kid is matched with three other campers as roommates for the week.

Additional instructions and requirements are noted on the application form. This scholarship has a value of more than \$1,600.



EAA CHAPTER 846 BOARD OF DIRECTORS MEETING SEPTEMBER 28, 2020

The meeting was called to order by President Matt Tomsheck at 19:04.

-Mustang Sale: Matt/All

Matt reported the Mustang was currently listed at \$120,000 as of September 27, 2020. One person has inquired about the Mustang since our last regular meeting, and came to look at the plane on September 19, 2020 at the chapter hangar. Matt reviewed the remaining time left on the contract with Bill Koleno and discussed renewing the contract. Matt pointed out that as part of our contract, Bill Koleno will do a check out flight of the Mustang as part of the sale. He noted the advantage of having this as part of the contract.

Gary Baker made a motion to contact Bill Koleno about extending the contract through January 31, 2021, with a no lower than price of 110,000. The Mustang would be kept at the current \$120,000 price until December 1, 2020, and then lowered to \$110,000 until January 31, 2021. The motion was second by Randy Brooks. The motion passed unanimously.

-Air Academy Coordinator: Matt

Matt reported that Art Hernandez is resigning as the Air Academy Coordinator. We will need to find a replacement. Matt will announce that the position is open at the October regular chapter meeting.

-Chapter Chili Fly-in: Randy

Randy reported the decision to cancel the chili fly-in for this year due to COVID concerns. Steve Zaleski indicated he is willing to host it in 2021.

-Christmas Party: All
