## **Shop Notes**By Doug Weiler

Just in case you have been hunkered down in the basement working on your RV the past few months, it's 2024! And... if that is not sobering enough, it just so happens to be an election year. And... with all of the inherent hoopla that brings, right at the top of the "hoopla" list is "AGE." You know what I mean... "Your guy is too old." "No, no, no, *your* guy is too old." So if your guy is too old and the other guy is too old, what about us RV drivers of a "certain" age? Are we getting too old?

So who is that nerd in that 58-year-old photo with the high-water pants proudly standing in front of that ancient Cessna 150? I'll let you figure that out. Back then, being God's gift to aviation, the last thing on



my mind was being too old to fly.

So how old is too old? A few months before I retired from that now obscure hometown airline, it was my leg on a dark and stormy night landing on 12 right at MSP. The wind was howling, it was pouring rain, the windshield wipers were flapping back and forth and I could hardly see where we were going. We were rockin' and rollin' coming across the fence and I was thankful that the 757 handled like an RV at slow speeds. We plopped down somewhere close to where we belonged, into reverse, on the brakes and as we made the Alpha 4 turnoff and the blood pressure wound back down, I thought to myself, "Self, you know maybe this really is a young man's game."

Our builder's group dates back to the late 1980's and since then there have been a number of our RV builders/pilots who have "aged out" and retired in one form or another. Sometimes it has been medical issues that had forced their hand. Or simply the decision is made at some point that it is time to hang it up, sell the RV and go fishing.

At 75, I am just beginning to realize that there is a finite point to one's RV flying. Tom Berge and I have talked bout this a lot. I have discussed this with my long-suffering co-pilot/wife. Right now, I cherish every opportunity to fly my RV-7. I am adamant that I HAVE to fly at every opportunity I can to stay as safe and proficient as possible. That means practice, practice, practice. But I am realistic that it can't go forever. But for now, I feel great, flying is still a blast and I'm looking forward to a few more trips and a few more pancake runs.

Several years ago, I saved this post from Van's Airforce. The author is Randy Pflanzer who built two immaculate award-winning aircraft, a F1 Rocket and a RV-12. For your consideration:

#### Flying Passion – A Cautionary Tale

I will try and keep this as brief as I can. If you are a current builder and not flying much, or the owner of a finished bird and you fly less than 50 hours per year, this tale is for you.

Like many of you, I took my good health a little for granted. I took all the precautions, ate right, didn't drink or smoke, and visited my doctor regularly. I was a picture of health right up to 58 years old, then WHAM. Long story short, in 2012 I dealt with the aftermath of having Stage 4 cancer and the impact chemotherapy treatments had on my body. I was able to initially deal with these challenges and even built my RV-12 as a mental recovery treatment

but ultimately, I had to give up my passion entirely in 2016. Fortunately, in my 30 years of aviation, I was able to achieve nearly all my goals and dreams. I built multiple times, won an award at AirVenture, and visited 42 of the lower 48 states.

My point to all this is to remind you that your aviation future is not a foregone conclusion. God has a way to setting you on a different path than what you have planned for yourself. Get that RV out of the hangar and go places, fly, enjoy the freedom, whatever drives your aviation passion, just DO IT. Tomorrow may not be an option. Do I miss aviation? Every single day. Every time there is a CAVU day, or I hear an airplane fly overhead, I think of all the great times I had going places, meeting great people, and seeing our country from 3K feet. I miss it dearly and would love the opportunity to engage in my passion once more. But that's not going to happen, and it's an outcome that all of us ultimately face somewhere down the road.

Now, I didn't write this so anyone would feel sorry for me. Don't. I'm doing fine and I use my energies on different passions now. I bought a business with my two sons and it's going great. I also have four grandsons under 4 years old that love to go fishing with Poppy. My life is wonderful even without aviation. But don't take circumstances for granted. Get your bird finished or drag it out of the hangar and dust it off. Top off the tanks and launch!

## **Chapter 846 Tool Room Comes Together!**

On Saturday, 17
Feb., we had a
very good turnout at the Chapter hangar to
start remodeling
the new Tool
Room, which was
recently enclosed



by the work done over the previous year of adding an observation deck directly above this new room.

Work started by removing most everything from the room which was no easy task since many things were quite old and heavy. It was decided that one large old metal cabinet, and another old heavy tool, had no use anymore so they were loaded onto **Dave Manning's** 



pickup truck to be scrapped. Many old manuals and files were extracted, and **Gary Baker** sorted through them, throwing away the very obviously outdated stuff, such as a healthy collection of VCR tapes. Only

three heavy tools were left in the room and were worked around - a metal shear, a 48 -inch bending brake, and a horizontal bandsaw, all of which need some restoration.

Insulating of the ceiling and walls began by stapling fiberglass insulation into the ceiling bays, and fitting and

partly gluing into the walls. Finally, 3/4" plywood was cut, fit and screwed to the two new wall studs. Present were **Brad Wurst** (who arranged and supervised the effort), **Gary Baker**, **Steve Bauman**,

Two weeks later, on March 2nd, yet another great team assembled to continue and nearly complete the restoration. On this day, the ceiling was completed with steel panels and ceiling trim (only a small section in the N.E. corner still needs some work). Then besides disposing of a lot of trash, a big organizational effort resulted in carefully dividing all the existing tool room contents into categories, those being; aircraft tools, non aircraft-specific tools, high value tools, reference books and chapter history.

It is now recognized that we need good storage solutions, cabinets and such, for all of the above, including the ability to lock up some of the most expensive tools. Also created was a collection of "last-chance" stuff such as building materials and old books that will be available to claim at our March 14 gathering.

Still needed to be done is electrical work (adding lights, receptacles, a switch), finding/purchasing cabinetry and installing and loading them up, and a good final cleanup of the whole hangar - plus again, we need work done to the heavy tools mentioned above.

Present were **Brad Wurst** ( who again organized the effort), **Seth Alvis**, **Kevin Fink**, **John A. Watts**, **John M. Watts**, **Rob Trout**, **Dave Manning**, **Randy Brooks**, **Gary Baker**, **Dale Holmes and Gary Kohler**.




long drive to Oshkosh, there is no need to drive around Camp Scholler looking for an empty plot of land to claim.

Most of the parts are painted now, with the engine cowling, wing tips and a few odds and ends left to paint. We recently assembled the wings to the fuse-

lage and mounted the horizontal stab and the vertical stab with rudder attached. It's looking like an airplane again. I've gathered most of the paperwork needed for my Airworthiness inspection as well as starting the online application. #### **EAA Build and Fly**



# Noble County Airport awarded RAF Grant for Phase Two Improvements

RAF Ohio Liaison Christine Mortine used an RAF grant in 2020 to initiate improvements at this airport near Caldwell, Ohio. It is a desirable recreational destination that provides walking access to Noble County's Wolf Run State Park campground. Pilots can tie down and follow a wooded trail to the lake. The outhouse was improved, and carts were obtained for visitors to haul camping gear from their parked aircraft to the camping area. Regrading and drainage of the additional parking area is underway. A visitor sign-in box was added to record pilot usage. During the summer months 10-25 sign-ins are recorded each month. Mortine monitors the record and says, "Heartwarming messages from campers and picnickers sharing their enjoyment of the spot and their plans to return, only make these approved improvements all the more exciting."

Mortine will use the 2024 grant to enlist volunteers to work under the direction of airport manager Ed Crock, who operates a construction company. "The Wolf Run Fly In camp area has proven to be a highly energized project with mounting support and enthusiasm for Phase Two," Mortine said. Planned improvements include an open-air pilot shelter with concrete floor large enough for several picnic tables, and adequate storage for carts, kayaks, paddles, life jackets, and bikes. The plan is to add an RAF fire ring, and at least three wooden tent platforms closer to the lake's edge within the more wooded environment.

"There is full throttle involvement of the Noble County Board of Trustees, Ohio Department of Natural Resource State Parks division, and the RAF," Mortine added. For more information on Noble County Airport, see the <u>Airfield Guide</u>.




