## Ford Tri-Motor Tour Stop - Final Report

Since we did not publish a December newsletter and not everyone was able to attend the December membership meeting where Doug gave an update, we thought we would include a final report on last September's Ford Tri-Motor Tour stop.

First, the really good news whicht Doug relayed at the meeting. Because we met the minimum sponsorship goal and because the turnout was so great that we flew 47 flights, the \$5 share per revenue seat that we earned netted us a check for \$1,880 from EAA!

At last week's Board meeting, Doug told us he had been contacted by the new Air Tours Coordinator at EAA and she asked Doug to complete a survey on what went well and not so well for the event. As for positives, Doug mentioned the enthusiasm and cooperation of the Airport

Commission, AOPA, Landmark Aviation, the local Ford dealer and other local businesses, the Tri-Motor flight crew and last, but certainly not least, the terrific response from our Chapter membership. The lone negative he mentioned was that advice and materials from EAA were difficult to obtain and slow in coming (although in fairness, this might have been due to the re-organization going on in Oshkosh).

As for a return of the tour stop in the future, while both we and EAA are positively disposed to such a thing, it probably won't happen in 2014. One reason is that the Air Zoo's aircraft (the one that came here) is being withdrawn from the tour so that EAA's Tri-Motor will only be one touring next season. A second reason is that it's probably better to not have another visit so soon in order to let anticipation build for the next time around.

## **January Board Meeting Notes**

When we arrived at the hangar for the meeting, we found a Christmas card from the Frederick tower controllers. Mark has posted the card on the bulletin board.

Mark reported that he had been contacted by the head of the local Ninety-Nines Chapter, which is sponsoring this year's Women Fly-It Forward event to be held at Frederick on Saturday, March 8. She said the theme this year will be focused more on education than actual flying. She is interested in our support but it's not clear yet just what that will entail for our Chapter. Mark will be following up to get more information.

That date, March 8, conflicts with our original banquet plan. The Board felt that having both events on the same day was not practical so the vote was to move the banquet date to Saturday, March 15. The details for the banquet, including the venue, have not been finalized yet but will

be soon.

Doug Kelly mentioned that he had heard from a local contact for the Collings Foundation who said that they were interested in bringing some of their aircraft to Frederick. This was a very preliminary discussion, Doug has not broached the subject with any of the airport parties yet and it's too early to know what the implications would be for the Chapter. He will get back to us when he learns more.

Jack Fromm gave a report on what he has learned so far in his effort to obtain non-profit status for the Chapter (see the separate report on those findings in this issue).

Joe Halleman mentioned that he might be interested in bringing his project into the hangar for final assembly. He and Mark will discuss further.



## **Initiative to Obtain Tax-Exempt Status for Chapter**

For some time now, there have been off and on discussions about the possibility of obtaining 501(c)(3) tax-exempt status for our Chapter. There are obvious benefits to this and EAA National is encouraging all Chapters to do it. However, it is a lengthy, complicated and potentially expensive process. Until now, those roadblocks, especially the financial one, have prevented our taking any real action on such an initiative.

A few months ago, I volunteered to take on the project to see if I could get some firm idea on just what was involved. Some preliminary discussions with personal contacts lead me to believe that it might be less complicated in our case because of our existing association with the Aviation Education Center, Inc., which already had 501(c)(3) status.

Newer members might not even be aware of the existence of that corporation so some background is probably in order. It was founded by Chapter member Chic Chaconas and in 1993, several of our Chapter members were appointed to its board so that the AEC could assist with projects that furthered aviation education for our Chapter. In 2002, when we were forced to look for a new home, it basically made the renovation of our current hangar possible by allowing us to solicit tax-deductible

contributions from local businesses and individuals. Since the missions of AEC, Inc. and Chapter 524 had become so closely linked over the years, it seemed appropriate to try to merge them, or at least make a name change, if that would simplify the process of transferring tax-exempt status to the Chapter itself. To that end, I asked for some assistance from some contacts at EAA to see if they could determine if that was feasible. The first order of business was to check on the current status of AEC, Inc. with the IRS because it had not had any income for several years. Unfortunately, when EAA looked up the information, they found that the tax-exempt status had expired.

The Board still wants to pursue obtaining tax-exempt status for the Chapter. We will just have to go through the process of incorporating and applying for that status in the standard way. The AEC did have a balance in their account and Mark has requested that the Treasurer write a check for that amount to the Chapter. If we do require professional legal or accounting services during our application process, we can use those funds to pay for them.

We will keep the Chapter apprised of our progress. If any members have any expertise in this area, your assistance will be welcome. Please contact Mark or me.


