ADS-B: Not a savior , but a new tool for the bag

January 1, 2020, has come and gone and for those who are blessed to use our National Airspace System, that means the new ADS-B Out rule is now active. While there have been some early adopters, there still remains a large portion (the FAA estimates around 50% of the GA fleet) of aircraft that haven't adopted the new rule. Some luddites don't want it. Others simply don't need it. But there's no debate the added safety benefit for those with the extra ADS-B In functionality exists. And with the warmer months approaching in pilot-dense Florida with our abundant breakfasts and lunch flyins, there are bound to be more hazards.

ADS-B is not intended to replace visual scan, but it is now an instrumental tool in aiding our scans. You can slice a smaller part of the sky to look for a specific target in addition to checking the rest of

your periphery. Has this helped? Immensely. A mere minutes after equipping my aircraft with ADS-B Out I initialized my ADS-B tablet. It displayed a target broadcasting nearby, with 0 airspeed and altitude. A few minutes later, I made my standard radio calls for taxi, crossing runways, and back-taxi for the uncontrolled airport where I was at, without so much as a peep in reply on UNICOM. As I began to back taxi up the inclined runway (which blocked view of the other end of the runway), I glanced down and noticed the ADS-B target's speed began increasing. It didn't take long to realize the aircraft was beginning its takeoff run. and in my direction. I quickly exited the runway and sat in the grass, no hazard existed, but there's no doubt ADS-B aided me in identifying the target a good 15-20 seconds before I was able to get visual on it.

My take home on this new tool? Use it in conjunction with our other safety items. Keep your visual scan up. Not everyone is equipped, including those turkey vultures. Use your radio and make standard non-controlled radio calls as well as use flight following in cruise- Jax Center is more than willing to give us another set of eyes for Mode C targets. And include your electronic display in your scan (safety permitting) to make sure you aren't on a collision course with another ADS-B Out aircraft. It'll keep for friendlier skies.

I have been working on this Fisher Celebrity project a little. The firewall and engine mount are fitted along with the main fuel tank. The fuel line

from the tank to the gascolato r has been fabricated and installed.



The fuel shut off and elevator trim controls were fabricated, and the cables were fitted and installed. I put the rudder, horizontal stabilizer, and elevator temporarily to check fit and to get the proper length for the elevator trim cable. Several brackets for the upper wing mount tubes have been fabricated. The lower wings and ailerons are mostly complete.
