Flying Club Update

Here's the latest on the Lil Angel status.

If you missed the update at the Christmas party, here's the latest. I filed for a 501c3 charity back in July. The purpose of his filing is that the Chapter cannot own a flyable airplane per National EAA regulation. So, when the bird is deemed airworthy it must be moved to another charitable organization. I think that Lil Angel will be airworthy in the next couple of months, "MAYBE". I filed for a 501c3 back in July. It typically takes 6+ months to get approved. With the recent government shut down, who knows when it will be finalized?? Once it is final, we can transfer Lil Angel from the Chapter over to it as mentioned above.

Once airworthy, I plan to put several hours on it for "confidence" purposes before passing it along to a club. Speaking of a club, most advisors have advised me to sell it to a club rather than lease it out. This makes sense to me mainly due to various possible liability issues. Based on this advice, my intention would be to sell it at what it ends up costing to restore. At present, this is approaching \$15,000. I see two ways to approach this. First is a direct buy, the second would be to buy it on a note. Either way, the funds will be turned back over to the Chapter. It was suggested that I get an appraisal on it in order to establish a fair market value. Good advice. Does anyone know an appraiser that will appraise it at a reasonable fee?

In terms of setting up a club, I will defer to someone else for that as it might be perceived as a conflict of interest if I do it. On the other hand, I've set up two partnerships in the past and will assist in any way. I'd suggest no more than 8 to 10 members, mainly for scheduling reasons, but there are clubs out there with many more. This past Saturday (2/2) I met with 4 Chapter members who have expressed interest in a club. Since that time, one has withdrawn.

Find attached a spreadsheet I've been working on. The principal numbers are my best guess and obviously subject to change, but should be a reasonable base from which to start.
