




New Members – Please welcome new members, Gary Wall of Kyle and James Swisher of San Marcos.

EAA BUILD LOG

Thank you Mr. Stan Timmerman for providing this informative article!

A resource that I have only recently become aware of is the EAA Build Log system. I have switched over to that system. I have yet to transfer my older stuff over but I like how the EAA site works. My public build log can be seen at: <https://eaabuilderslog.org/?s=Patrol>

For my log, I had been taking pictures but I was not very good about tracking hours. The eaabuilderslog.org site allows you to have multiple projects and multiple builders. You can search for other builders in the local area. You can also search the country for your specific airplane type.

The site is somewhere in the cloud – whatever that means. I guess it means that the data and requisite backup is someone else's problem. There does not seem to be a data limit that I can upload to the site. I can keep some of the information private so that only I have access to it. For example, I digitized the drawings in case I lose the set I purchased. I am the only one that can view that proprietary information. The electronic copies of my drawings are forever stored somewhere far away.

One of the useful features – other than it is free for EAA members – is that I typically use my cell phone while building. I can open up an entry form on my cell phone and enter info like: money, hours, and build activity. I then can enter a picture, video, or spreadsheet at that exact time. Then push a button and the log entry for your project is done.

I can always use a computer at a later time to access and edit the entry if I want.

I do not wish to be morbid, but if you do not finish your project, it is only of value to someone else if they can provide documentation that it meets the 51% rule. By using the EAA build log, you have a ready to go document that makes it possible for someone else to take over the project.

The FAA 51% rule is a real consideration for builders. You cannot buy wings from an old Cessna and attach them to your home made fuselage and have the FAA accept your project as an experimental home built. You have to be able to prove that the project was 51% amateur built. Even if the fuselage alone was 51% of the total, you will not meet the requirement of having built 51% of the Cessna Wing. Companies that sell kits must prove to the FAA that they have left 51% of the tasks to the builder to finish.
