## **2021 Chapter 1093** **Scholarship** **Nominations Now Open**

Chapter 1093 offers two types of scholarships:

- 1) toward completion of a pilot certificate and
- 2) toward completion of a mechanics certificate.

Individuals seeking a scholarship (Application) and those seeking to recommend an individual for a scholarship (Recommendation) will find the appropriate forms under Scholarships on the Chapter 1093 website, <https://chapters.eaa.org/ea1093>.

Submission information is at the bottom of each form. Scholarship applications and recommendations will be accepted through the end of March of 2021. Awards will be announced during the Pancake Breakfast currently scheduled for May 1, 2021.

### **Nominee requirements:**

- Must be recommended by at least one current EAA Chapter 1093 member.
- Must live in Midland or the surrounding area.
- Must be minimum age 15.
- Must be pursuing a private pilot, recreational, sport pilot license, advanced flight training, or attaining an aviation maintenance certification.

### **Additional factors to be considered:**

Nominee's interest and active participation in Chapter 1093 activities,

- Nominee's attendance or participation in Chapter 1093 Aviation Camp
- Nominee's sincere and persistent determination to pursue a career or avocation in aviation,
- Nominee's current use of own funds for training, and Recommendations submitted in support of the Nominee.

## **Piper AD Addresses** **Wing Spar Fatigue** **Cracks**

In January, the FAA issued an Airworthiness Directive (AD) for certain Piper PA-28/-32 models prompted by a report of a wing separation caused by fatigue cracking (<http://bit.ly/36H9M3i>). The AD requires calculating the inspection requirements, inspecting the lower main wing spar bolt holes for cracks, and replacing any cracked main wing spar. It is effective Feb. 16, 2021. This AD follows closely to another Piper wing spar AD issued in November 2020. ## **FAA Accepting Applications for Aviation Workforce Development Grants**

The FAA is seeking applications for two Aviation Workforce Development Grant programs aimed at developing and inspiring a more inclusive pool of pilots and aviation maintenance technicians to join the next generation of aviation professionals.

The Aircraft Pilots Workforce Development Grants provide money to expand the pilot workforce and educate students to become pilots, aerospace engineers, or unmanned aircraft systems operators.

The Aviation Maintenance Technical Workers Workforce Development Grants will help prepare a more inclusive talent pool of aviation maintenance technicians. Applicants from academia and the aviation community can submit applications to [www.grants.gov](http://www.grants.gov) through March 22, 2021. Potential applicants are encouraged to visit [www.faa.gov/go/awd](http://www.faa.gov/go/awd) to review frequently asked questions, eligibility requirements, and guidelines.

## **EAA 1093 Board Meeting** **Minutes** **February 18, 2021**

President Sarah Pagano declared a quorum present and called the meeting to order at 1706 EST. The Board meeting was held via Zoom.

Directors in attendance: Dave Fick, Jeff Gallant, Sarah Haskett, John McPeak, Chris Pagano, Sarah Pagano, Tom Ryden, Dick Sipp, John Sorg

Directors unable to attend: Brandon Haskett, Brandon Marks, Paul Ries

Guests: Linda Langrill, Don Bonem, Dot Hornsby, Jim Murphy, Dave Bickmore

Minutes from January 21, 2021, Board meeting were approved as submitted; motion by Gallant/Fick

Treasurer's report: Treasurer Marks reported (via e-mail) that the Comerica signature cards have been signed and he will be disbursing checks soon. A subscription to QuickBooks will be purchased for ongoing bookkeeping. 2020 has been closed:

Insurance was paid from 1093 account in 2020: \$3,582.

Scholarships awarded in 2020 were greater than in 2019 and scholarship donations were less in 2020 than in 2019.

Dues received in 2020 about \$500 less than in 2019.

A checking account is being established for scholarship fund deposits and administration.

Membership Committee report: Chair Ryden reported that silver name tags will be given to four members who each have been members for an initial five continuous years – Bill Church, John Coleman, Birgit Holicki, and Peter Tazelaar. Chris Pagano will receive a gold name tag for ten continuous years of service. Philip Sheridan submitted a



membership application and 2021 dues. Currently, 2021 membership stands at 61 members.

Hangar Committee report: Bonem reported that the Committee recommended an additional \$300 be added to the 2021 FBH budget for materials to replace rubber seals on 7A Fancy and 7B Cozy hangar doors. There are currently two spaces available in 7B Cozy; aircraft owners on the wait list are being contacted.

Committee will meet to continue transitioning Bonem's duties to new members.

Young Eagles report: Gallant reported February YE flights were cancelled due to pandemic restrictions.

Scholarship Committee report: Chair Murphy has submitted the Chapter application for a 2021 Ray Scholarship, acceptance (or not) will be later this spring.

Applications for 2021 Chapter scholarships are currently being accepted, the Chapter website (<https://chapters.eaa.org/ea1093/scholarships>) has forms.

#### **UNFINISHED BUSINESS:**

2021 budget discussions: President Pagano presented a preliminary draft of a budget for 2021. Following discussion and some uncertainty about various items, a decision was made to revise the budget and bring it to the March Board meeting.

Cessna 150A disposition: S. Pagano and McPeak reported that all co-owner signatures have been received, application for re-registration has been sent to FAA.

RV-12 build project: S. Pagano reported that there will be a kick-off event during the March 20 membership meeting with guest speaker Vic Syracuse. Motion by McPeak/Gallant that the fastener kit and

the empennage kit be ordered from Vans's Aircraft – motion passed. Delivery is expected by late spring. Membership will be notified of the March 20 meeting; attendance can be virtual or in-person in the Chapter building. Building insurance coverage/waiver of liability: Ryden reported that the ad hoc committee is waiting for a review of the prepared revisions by Mike Woodley. Credit/debit cards: McPeak reported that Comerica has issued new cards. Great Lakes Bay Invitational fundraiser: Ryden reported that application has been submitted, the selection of non-profits will be made in April for event in July.

#### **NEW BUSINESS:**

Resuming Chapter activities: President Pagano reported that membership meetings will resume beginning in March, subsequent meetings will be virtual until pandemic restrictions are relaxed to allow indoor meetings. Microsoft 2020 Flight Simulator: The Chapter's application to EAA for a free copy of software has been accepted. Chris and Sarah Pagano have offered to donate a computer and peripherals to power the software. Motion by Gallant/McPeak to accept the donation – motion passed. Thank you letter for donation will be sent to Paganos. Flying Start Day: May 15 has been designated by EAA as the 'official' Flying Start Day, a decision whether or not to participate will be made at a later Board meeting. President S. Pagano adjourned the meeting at 1805 EST.
