FROM YOUR PRESIDENT:

YOUNG EAGLES DAY NOVEMBER 4TH. That's right our annual Young Eagles Day is right around the corner. We need help, if you would like to participate as a pilot, or a member of the ground crew, we need you. We will start flying at 9 am, so plan on being at the airport around 8 am, so we can get all set up and ready. If you have completed the Youth Protection Program, check to see if your license is still valid or needs renewing. If you have not completed it, you can do that at eaa.org, or just come out, we have enough that have completed the course that ground workers would not be a problem. Pilots must hold a valid certificate with EAA and have the required insurance on the aircraft. Any questions on that please call Mike Olson @ 785-472-7200. We will fly from 9am until 1 pm. Following the last flight, we will hold our November meeting, which will be short, just to review the day and look forward to any other activities that are coming up. I hope you can be there.

The airport is now complete except for 13/31, which is still closed. With the parallel taxiway it should help with the traffic during take-off and landing. We plan to hold the event in the hangar, just more room. Which also means we will need to have a clean-up day. We will plan on that for Thursday November 2nd, at 1700 hours. We understand that those from other than Ellsworth may not wish to drive over for clean-up, that's ok. For all pilots the club will pay \$2.50 per gallon for fuel used during the event. So, make sure the tanks are full when you leave home and fill them after the event. We will set the price back \$2.50.

Fall days are here which means there are some great flying days, especially the morning and evening. Hopefully our YE day will be one of them, but it is Kansas so you can never be sure. Be sure to come out, we can use your help, this is a great event, and it is anticipated by the community, so if the weather is good we should have a lot of Young Eagles.

I was able to take a cross country trip to Garnett Kansas recently for their fly-in and took Patti Kubick along so she could visit with her daughter. Great trip, only problem we couldn't see the airport. While Patti and I were looking and not seeing it, my wife in the back said, "It's right there". And it sure was.
