This month's activity is the annual Pig Roast in Benton, Pennsylvania (PA40) on Saturday, October 19th.


The flights would originate from their base airports, rendezvous at St. Mary's Airport (OYM), and have breakfast at the West Wind Restaurant.




This is followed by a fuel stop at William T. Piper Memorial Airport (KLHV) in Lock Haven.
