## **ATTENTION: PROPOSED NEW RULES AT BEND MUNICIPAL AIRPORT**

The Bend City Council recently published a draft document called “City of Bend, Oregon, Bend Municipal Airport, Rules and Regulations Minimum Standards and Leasing and Development Policy.” These new rules will have a negative effect on the flying public and by extension many of our chapter members.

The city has given a short 30 day comment period that expires at 5pm on December 8 for the proposed ruling. If you agree with our assessment, we encourage you to comment on the official form expressing your displeasure with the draft. Comments can be submitted through the city website by clicking [here](#). The full text of the proposal is also available through this webpage by clicking on “Rules and Regulations, Minimum Standards, and Development and Leasing Policy”.

Reading through the document, five clauses stand out as being possibly detrimental to our chapter members as well as Bend pilots in general.

**Section III.4.7** specifically prohibits independent flight instruction. If a flight instructor does not lease property at the airport, he/she cannot perform flight instruction. The result would **outlaw most of how pilots get their biannual flight reviews and refresher training.**

**Section III.4.6.1.1** states that all flight schools must lease at least 200 square feet of space from the city. All flight schools must own or lease at least three certified airplanes with one being capable of IFR. All flight schools must operate under 14 CFR 141. (think Leading Edge) and therefore we assume does not allow instruction under Part 61. **This would stop our current Ray Scholarship students.**

**Section III 4.6.1.1.3** only allows flight instruction under part 61 (think Specialized Aero Works and Bend Aircraft) if the airplane is owned by the student and with permission from the city. Why the city would want to be in the approval loop for flight instruction is a great question.

**There are two other sections under III.4.5** that only allow aircraft maintenance at a part 145 repair station. Independent A&Ps and maintenance under part 43 is not allowed. Maintenance under part 43 is probably the majority of maintenance and repair performed at KBDN.

This article does not go into the **significant changes to hangar lease arrangements** which could impact members even more than the above issues. The [Friends of the Bend Airport](#) organization can provide information on the changes associated with hangars and leasing.

In addition to commenting on the aforementioned issues via the city website form, opponents of these new prohibitions can attend one or both of the following meetings at the Bend City Council Chambers located at 710 NW Wall Street:

**Wednesday, November 29, from 5-7pm: Open House/Informational Session** hosted by airport manager Tracy Williams and other city staff. They will make a presentation, then open it up for questions.

**Wednesday, December 6, at 7pm: Bend City Council meeting.** There will be an “Open mic” period shortly after the 7pm meeting start. Members of the public who wish to offer public comment may do so in person, by phone or by registering on Zoom prior to the meeting. Speakers will have 2 minutes. 5 persons voiced “Protest” comments during the last council meeting.

## From the Desk of the Bend Airport Manager

### **BEND AIR TRAFFIC CONTROL TOWER UPDATE**

On October 4, the Bend City Council approved a contract of nearly \$1.4 million with the architectural and engineering firm of Morrison-Maierle to design a new air traffic control tower for the Bend municipal airport. Bend's airport is one of the busiest in Oregon but has no air traffic control tower. The addition of a control tower is a vital safety improvement. The total project cost for design and construction is estimated to be \$15 million. Funds are expected to come from federal, state, and local sources, including grants. The project has already cleared several important hurdles, including Federal Aviation Administration (FAA) and environmental impact reviews. Project completion is anticipated in the fall of 2025. Future ATCT updates will be provided on the airport website throughout the duration of the project.
