Chariton makes aviation history --- sort of





Chariton was the place to be on Thursday, Oct. 22, 1931, if (No. 1) you were interested in a bargain and (No. 2) wanted to see up close and personal the latest in flight technology, courtesy of The Des Moines Register & Tribune Co.

The Register's Pitcairn autogyro, Good News III, piloted by Charles S. Gatschet, obviously was a gimmick to promote the newspaper (it visited 112 lowa cities that year). But when partnered with local folks who had products to market everyone came away happy. In Chariton's case, the town's

commerical club had organize a giant Dollar Day sale.

The autogyro looked something like a helicopter, but wasn't. The rotor blades were not powered by the plane's engine but rather the upward thrust of air diverted from its drive propeller.




