

## Fun, yet Docile



## *Only 176* Days to Oshkosh!





David Karlson learned to fly at Hales Corners Airport in the early 1970's. Fellow member Carl Gollnick started him on his aviation journey with lessons and an eventual check ride before the end of the decade. David eventually worked his way to his instrument, multiengine, commercial, and ATP ratings. He has been a member of the Experimental Aircraft Association since he was 12, and got engaged in Chapter 18 during his high school years, but trailed off to do other things. When he decided to scratch build an aircraft in 2009, David came back into Chapter 18 for good.

David wanted his own plane to enjoy personal aviation. He wanted something fun to fly, but docile and not 'much of a handful". The Acro Sport II, designed by Paul Poberezny, fit the bill. The plane was also featured as a project in the EAA School Flight program and David figured, if high school kids could build it, he could too.

The Acro II, is a two-place larger version of the single-place Acro-Sport. It features an M-6 airfoil with a 43 inch chord. It has large wheels, wide landing gear and a light gross weight. It is considered a fun, docile sport airplane designed for engines ranging in power from 115 to 200 hp. When fitted with a 180 hp Lycoming, its empty weight of 875 pounds makes it one of the lightest custom-built airplanes. The cockpit is designed to be comfortable for pilots up to 66 inches and 240 pounds. The airframe is somewhat larger than most biplanes to avoid "touchy" flight characteristics and allow for more baggage.

### RAY AVIATION SCHOLAR

Matthew Romuald here with an update on my most recent achievements and activities with the help of Chapter 18, the EAA, and the Ray Scholarship association.

With the help of the Ray Aviation scholarship my most recent achievement is the completion of all of my long solo cross country flights and all of my required cross country time. I have also been working on ground lessons in preparation for my oral exam.

For my solo long cross country I flew Spring Cities Cessna 152 from the Waukesha airport to the Manitowoc airport to the Appleton airport. I had been chasing this flight for quite a while. Several times I had this flight scheduled, only to have it cancelled due to weather or cancelled due to maintenance. At least I made the call on go no go situations, and as excited as I was to complete this flight, knew the flight planning and cancelling was good practice. Luckily all the stars aligned and I was able to complete my flight on December 20, 2020. I started my flight in the afternoon and I landed back at the Waukesha airport right after sunset. In my opinion it was one of the most beautiful flights that I have ever been on.

Due to my two solo cross countries taking slightly less time than expected, I had to make a third cross country flight, in order to achieve my 5 hours of solo cross country. My third solo cross country was to the New Holstein airport (8D1). I made this flight in the morning so it was also an amazing flight. Although, I think that this was one of my most nerve racking flights as well, this was mainly due to the fact that I hadn't been to the New Holstein airport. Finding an airport like 8D1 in the snow when the only thing that is plowed is the runway and parking pad was, in my opinion, very interesting and challenging.

Most recently, my instructor Tom and I have been going over the ACS oral test standards. We have been talking about what questions I might be asked and how I should answer them. After I feel comfortable with my oral knowledge I believe that I will be ready for my check ride. I already feel confident in my flying abilities. Recently, I have also received my Lightspeed Zulu 3 headset from Lightspeed Aviation. This is part of a program that lightspeed aviation runs in conjunction with the Ray Aviation Scholarship. As a part of your flight training as Ray Scholar, after you have completed your first solo and after you have passed your written exam you will receive a Zulu 3. This entailed paperwork, so call out to Tim for assisting me in making this awesome opportunity a reality. Thank you, Tim!

Overall, my plan for the coming month is to complete my simulated instrument time so that I will have all of my prerequisites for my check ride complete. After I have completed this I will be ready for my check ride, which weather and aircraft permitting, I plan to have completed by late January. I am really looking forward to completing my flight training and earning my pilots license!
