Flight Advisor and Eagle Flight Leaders

Nominations are being received for an EAA Flight Advisor. The primary qualifications to be a flight advisor are experience and the willingness to pass that experience along. It is not mandatory that an advisor be current as a pilot. To be a flight advisor, he/she must apply and conform to any one of the following experience measures:

Minimum 500 hours (Ultralight pilots need a minimum 300 hours) combined with flight testing ("phase 1") experience; or

Minimum 1,000 hours PIC time and significant experience in sport aviation aircraft (i.e., homebuilts, vintage, warbird, ultralight, etc.)

Departing KAZO without a squawk code.

Problem: You have just finished fueling up at KAZO and you intend to depart to the west to fly along the lakeshore to enjoy the setting sun. Is there a simple way to depart KAZO without obtaining a squawk code and flight following? Yes!

Solution: Request NEGATIVE TRSA SERVICE, or make a similar request, on ground. From the gas pump, contact the ground controller on 121.9, tell her who you are, where you are and that you intend to depart to the west. Give her your requested altitude and request NEGATIVE TRSA SERVICE. Ground control will confirm your request and state, "Advise when ready to taxi."

Guidance comes from the AIM, 4–1–18(b)(2) *Terminal Radar Services for VFR Aircraft*, which states:

2. If any aircraft does not want the service, the pilot should state "NEGATIVE TRSA SERVICE" or make a similar comment, on initial contact with approach control or ground control, as appropriate.
