Membership Meeting Minutes Summary

February 25, 2020

The February meeting of the Falcons was held at the CAF hangar at Falcon Field, Mesa, AZ.

President Trent Heidtke brought the meeting to order at 6:55 PM. There were 45 members and guests in attendance.

Trent opened the meeting with a reminder that the EAA has flight training scholarship money available. Go to the EAA.org website for more information.

Lynn S. from the airport administration announced that several organizations responded to the request for proposals for occupancy of the old WWII hangars/office space. Also, construction of the new hangars on the north side will begin in March and the Falcon Field Open House will be on March 28, 2020. If you would like to display your aircraft, fill out the waver forms available at the administration building.

Trent asked Mike C. to introduce Tim O'Hara-Haworth, our candidate for the Ch 228 Scholarship to the EAA Advance Aviation Camp at Oshkosh on July 24-Aug 1. Tim is 16 years old and is active in the JROTC at Westwood High School and Aviation Explorer Post at Falcon Field. In his first year of JROTC, Tim was voted by his peers to be one of

two Cadets of the Year. He has accumulated 45 hours of flight training and is studying for the PPL written exam. He hopes to attend the Air Force Academy. Congratulations to Tim.

Trent asked if anyone had a maintenance issue they need help with. Also, if you ordered an EAA calendar, see Don C.

Trent announced that we are looking for a larger venue that we can use free of charge. If anyone has a suggestion, please let him know. The CAF annual Big Band Dance will be March 14<sup>th</sup>. Although usually limited to CAF members and family, they are offering chapter members the opportunity to attend for free if they volunteer for a 3 hr work shift. The sign up sheet is on the bulletin board by the entrance. Those who attended last year had a really great time.

Trent asked for motion to accept the January minutes as published. The motion to accept was made and passed.

Trent asked for guests/new members to introduce themselves.

Tim O'Hara- is our scholarship recipient.

Also with Tim was his brother Ben, who is also interested in learning to fly, and mother, Shannon.

Welcome guests and new members!

Next Trent gave a shout out to Gary C. for taking a kid on a YE flight.

Trent asked builders present tonight to give an update on their project.

Keith P. is "almost" done filling and sanding his Velocity.

Gene M. has his PA-22 restored but the pilot is not ready yet.

Alex and Kim H. are working on fuselage of their RV-7. They may need to borrow a tube bender soon.

Monti H. has decided to stop his plan for a scratch built Mustang II in favor of a partially completed kit he recently purchased.

Trent listed the monthly flying activities. The Cactus Fly In at Casa Grande will be on March 6-7. A pancake breakfast will be at Aguila on March 14<sup>th</sup> and the APA fly in to Grapevine will be on March 20-22.

Jim T. briefed us on airspace. The Stagecoach AAF helicopter base near Pinal Air Park will be getting a Class D soon (2500 AGL, 4 nm). This should eliminate accidental fly overs as the current chart warnings are often overlooked. We can also expect continued elimination of NDB and VOR approaches that are deemed under used. Also, Marana (AVQ) will be getting an FAA contract tower. Construction will take about 2 years.

Todd B. gave the accident report. A PA-28 (CAE aircraft) lost control during a soft field TO practice and hit a parked plane that also struck a Diamond Star. No injuries but a lot of damage. Cross winds may have been a factor.

Andy's safety briefing tonight covered runway safety. He started with a short video from AOPA which cautioned not to multitask while taxing. The AOPA has an excellent 7 part video on runway safety and Andy recommends you check it out.

Andy stressed preparation. Know the airport layout, listen to ATIS and monitor the ground frequency

before you taxi. This will help establish a mental picture of what is happening and what to expect when you call for taxi instructions.

At large airports, don't hesitate to ask for progressive taxi instructions. Check NOTAMS for airport/runway construction/closures. Slow down early when landing and make a stabilized approach. Pay attention to displaced threshold or runway touchdown markers. Consider density altitude/runway length to be sure you can safely operate.

Thank you Andy for tonight's presentation.

Bill W. announced the next YE events will be on March 7<sup>th</sup> from the terminal and June 6<sup>th</sup> from the Warbids hangar. Please come out to help, especially pilots able to fly YE's.

Tonight's program included two hands on demos. First, Gordon C. demonstrated how to balance a tire. Begin by cleaning the rim area with a good degreaser so the weights will stick. With the tire on the balancer, the heavy side will naturally go to the bottom. Put a piece of tape on the top of the tire to signify the light side. Gordon recommends using tape to temporarily position a pair of weights on either side of the light side mark. You may need to use several more weights to get a balance. When balanced, the wheel should stay in any orientation. Gordon recommends using an extra layer of double stick foam to the weights to ensure they stay put.

Gary H. showed us how to make a fiberglass repair. There are several different weaves of fiber glass: Bidirectional (BID), uni directional, plane weave (aka boat cloth, not used on aircraft), twill weave and harness weave. Using a damaged area on a EZ canard surface, Gary had prepared the repair area by sanding 2 inches beyond the

damaged area (1 inch per layer of cloth), tapering the upper layer into the bottom layer. He then had two layers of cloth precut. The larger piece should cover the entire repair area and the smaller piece the inner portion. Mix your epoxy and apply to the repair area with a brush. The larger piece of cloth is applied first and more epoxy is brushed on. When filled, the cloth becomes translucent. Then apply the smaller piece over top and brush on more epoxy.

Thank you Gordon and Gary for tonight's demonstrations.

Next we had the 50/50 raffle drawing. The winner received \$41. There was also a \$20 prize drawing for those that had pizza or a correct answer to the trivia questions. Congratulations to the winners.

The meeting adjourned at 8:30 PM.
