Membership Meeting Minutes Summary

November 24, 2020

The November meeting of the Falcons was held in the CAF hangar with a simultaneous webinar using the WebEx platform. President Trent Heidtke brought the meeting to order at 7:00 PM. There were 19 members at the CAF and 15 on the webinar.

Trent opened the meeting with an update on Falcon Field as provided by Lynn Spencer from the administration. First, some inprovements are planned for the picknic area including a much needed restroom overhaul. Crack sealing and east ramp construction is almost completed. Tenants will be getting new gate access cards. The Open House usually held in March has been cancelled. A series of smaller events are planned as a replacement. The next tennant virtual meeting will be on December 9th. The Falcon Field Administration is limited to telephone support only due to the Corona virus. Other airport businesses are open but may have limited hours. Please try to support them in these difficult times.

Trent continued with an update on the new hangar construction. Construction is moving along and most of the exterior framework for the new hangars is completed. At least one unit only needs the hangar door to be installed.

Sadly, the FAA was not able to review the medical for Scott Trisilla in time for him to use the Ray Scholarship. Scott will be looking into other EAA Scholarship possibilities for next year.

Shayla from the Falcon Field control tower is set to order tee shirts for a fund raiser. Please purchase some as a portion of the profits may be coming back to this chapter.

EAA calendars are available for \$12 each. If you would like to purchase one, see Trent. We also have received EAA "Oshkosh 2020" merchandise (hats, shirts, pins and patches). Tickets were sold to both physical and virtual attendees for a drawing later tonight.

A shout out this month goes to all the members who helped with the CAF Wings and Wheels event: Aaron Reger and Chuck Flint. (Thanks also to Trent for his help with the event.)

The Treasurer reports that the account balance is about \$5029.41. Chapter renewal this month will knock this down somewhat.

November is election month. Since there were no additions to the slate presented at the October meeting, a motion was made and seconded to accept the slate as presented. Trent said that some of the officers serving in 2021 will not be running in 2022 so please consider putting your name forth next October.

Next Trent gave an update on members build projects.

Alex and Kim RV-7 - have been focusing on installing avionic boxes and wiring.

Aaron W. RV-10 - fiberglass work on the right door/latch is done. They did an off design for the latch and it took a little longer to get it installed.

Aaron Walker also shared some pricing he got from Advanced Flight Systems (AFS) and as a result, they decided to let AFS build their panel.

The social dinners at Vito's on the second Saturday are on hold. Restaurants at most fly in destinations are open with indoor seating available. Thursday coffee (8:00 AM) has resumed.

Trent gave the airspace and accident news. Per Jim Timm, no new airspace issues. Be vigilant for TFR's (fires).

The NTSB sie is down so there is not much to report on accidents. The good news is that the experimental fatal accident rate is about 8% below the FAA target.

There were 3 incidents in the past month with none or minor injuries. No details available.

The next Young Eagle event will probably be in February.

Andy Elliott gave his safety briefing on Icing. Icing is especially dangerous for GA aircraft as most do not have anti icing capability. Inlet icing can result in power loss. Wing/tail surface icing will reduce lift and require more power to maintain altitude. GA aircraft can not stay in icing conditions for very long (go up, go down or turn around).

Ice starts as super cooled water droplets. The type of ice you can get depends on temperature and droplet size. Airflow over a wing or tail can reduce the local temperatures. It is possible to get icing at +2 deg C. Below -20 deg C, you can not get icing as water vapor can not be sustained. Typical weather conditions which produce icing is a warm moist front meeting a cold front. Ice formation occurs at the interface of the two fronts.

To illustrate the danger, Andy played a short video from VAS Aviation for a recent fatal crash at Lubbock, TX. The fatal was on the second attempt to an instrument approach in a C-210. Weather at the time was freezing drizzle, ceilings 800 feet and winds 15 gusting to 20 knots.

The pilot clearly did not prepare well for the approach which, as Andy illustrated, involves a lot

of equipment set up to be completely prepared. He may have been set up to land on 17, but the winds dictated a landing on 35 (he should have known this if he listened to ATIS). As a result, the pilot remained 25 to 30 minutes longer in icing conditions than he needed to despite ATC efforts to get him on the ground as quickly as possible.

Tonigths guest speaker was Keith Dorson talking about vertical flight (i.e. helicopters).

Keith began with a little background on himself. His dad was an A&P and his love of aviation was passed on to Keith (he remembers a model J3 in his crib). After college, he went to work at Hughes Helicopters, Culver City, CA. Here he got introduced to helicopters (Hughes 500). From there he went on to McDonnell Douglas as a senior financial analysist on the Apache, Notar 500, and the Light Helicopter Experimental. He started flying lessons at Chandler Airport and soloed in a C-172 but lost his CFI to a better paying job in Los Vegas.

Now at age 59 he's having a "mid life crisis" and decided to fulfill his dream of owning/flying a helicopters. He purchased an experimental Rotoway Exec. 162f. This was a Canadian bird, so he has been working with the FAA since last March to get the paper work/airworthiness straightened out. Along the way, Rotorway went out of business, but they are coming back as RotorX.

For mobility, he has acquired a 2016 RAM 2500 Diesel and is getting bids to build a custom trailer to haul his bird around. Future plans include, learning to fly his helicopter, insurance, and maybe a partner.

He has discovered that you need to network in the experimental community. He is establishing the contacts he needs to make his dream a success.

Thanks Keith and wishing you success in achieving your dream.

#### **FLIGHT SAFETY**

The Tucson International and Ryan Field Air Traffic Control Towers had been closed from time to time recently because of the Virus Pandemic, but now both are operating during their normal published operating hours. To be safe however, always check for NOTAMS before your departure to avoid an unexpected surprise on arrival.

#### FLIGHT SAFETY ITEMS

There are a few flight safety items that have come up that everybody should be aware of.

If you have a Cessna 120 or 140 there is an AD on the seat belt to airplane brackets that must be addressed. See the following notices:

The FAA is adopting an AD on several models of Lycoming Series 360 engine crankshaft assemblies that were sold by Superior Air Parts Inc. The NTSB sent out a notice that they have noted a number of accidents that have resulted from engine failures because of a loss of engine oil from engines equipped with a Stratus Tool Technologies Oil Filter Adapter. Pilots and owners are urged to comply with Service Bulletin <a href="SB-001">SB-001</a> before their next flight.

Because of the present virus pandemic, some of the airport restaurants may have take-out service available. Call ahead.

The fly in breakfast at Coolidge Municipal Airport (P08), is on the first Saturday of the month, and the Breakfast season is still on the schedule.

On the second Saturday of the month, Ritchies restaurant on Ryan Field (RYN) is serving breakfast after 6 am.

The Falcon Field EAA Warbirds Squadron fly in breakfast, and car show which was on the third Saturday of the month is still on hold awaiting approval from the City of Mesa to restart.

Grapevine is open full time, but the third Saturday of each month is a special time for a group camp dinner on Saturday evening. Come and camp for the weekend! 
