### EAA Chapter 228 Falcons Membership Meeting Minutes Summary August 22, 2023

The August meeting of the Falcons was an in person meeting at the CAU hangar. President Don Croyle brought the meeting to order at 7:03 PM. There were 30 members/guests present.

Don reminded everyone that there are 334 days to Oshkosh 2024. He then announced that we need someone to take on the role of managing our social media (e.g., Face Book, event calendar). We will be looking for volunteers at several events coming in the next months: B-25 in Glendale in October, EVIT STEM and CAF Dance on 11/4, Trimotor at Falcon at the end of November. Gary C. spoke about the EVIT STEM event.

Don asked for a motion to approve the June meeting minutes as published in the August Newsletter. The motion was made and approved.

Don asked any new members or visitors to introduce themselves.

Brian C. was a member before and is coming back to our meetings. He has a Thorp T-18 project that he may need help with.

Todd S. is with Explorer Post 352 at Falcon and is taking over duties for Bennet S. who has a new assignment out of the area.

Dee Anne from Falcon Field admin gave us an update on Falcon news. On 8/28 the control tower will be active M-F from 6 to 9 PM and 6-5 PM on the weekends. Mark Gibbs has joined the staff as Project and Ops manager. There are two drainage projects in the works. The one near gate 4/5 will impact access to hangars NN and OO. Check the Falcon Field website for more details. Modifications to runway access will be going on in October and November. Most of the work will be done at night. There may be some closures of the North runway. The next CAF family fun day is on 9/9 and the CAP blood drive is on 9/14 from 8 AM to 2 PM. The next ask the airport ZOOM meeting is on 9/20 at 10:30 AM.

Girls in Aviation Day celebration is coming and Ch 228 is welcome to have a table to promote YE

flights. Celebrate Mesa is on 10/14 from 5-9 PM and on 11/17 Helicomponents will host Aviation Fascination from 5-7:30 PM with free food tasting.

Falcon is starting a new program on the first Saturday of the month called Cockpit Closeup and need pilots to volunteer their aircraft to let some young kids sit in the cockpit. The annual Christmas airlift for the Navaho nation will be in November. They are adding Winslow as a drop off point if you don't want to make the longer trip.

Don asked Eric for an update on his RV-10. He is on hold waiting for replacement parts due to issues with laser drilled holes cracking.

Dinner socials are on hold for the summer and will return in the fall. Thursday coffee has moved to the Admin lobby (thanks Dee Anne).

Don summarized the pilot deviations and accident data. Pilot deviations continue to occur for all levels of experience. Of the 10 deviations, 7 Brashers were issued. There were 4 accidents/incidents last month but no injuries. See the APA Newsletter for more details.

Bill W. gave the YE news for Mike E. There were no individual YE flights in the past month. Contact Mike E. if you can fly individual kids as they have about 5 signed up for rides. The next YE event will be at Pegasus in October for EVIT. They will only need a few planes as several Pegasus pilots are flying. Ground crew are also needed. We have \$525 in 2022 YE credits that we need to spend this year.

There was no Treasurer report this month.

Andy Elliot gave a Safety Briefing on Maintaining currency. He began with a warning that there is a controller shortage and understaffing has led to some safety issues. Be extra alert to possible conflicts/questionable ATC instructions. Also, the FAA has updated AC 90-66C on non tower operations. Check it out.

There is a difference from what is legally current and what is safe to fly. Legally you only need a flight review of 1 hour every 24 months and 3 take off and landings in the previous 90 days to take passengers. Does this minimum make it safe to fly?

What affects safety? This includes aircraft factors (time in type both recent and total), environment (weather), personal factors (health, medications, diet, sleep, stress, etc).

Perishable versus durable skills. Durable skills can last for years. Perishable skills (such as piloting skills, instrument approaches, night flying, emergency procedures, go arounds) can fade rapidly.

How much should you practice? If you only fly one hour a week, that hour should be practicing your flying skills. This is especially true for pilots over the age of 50. You should include the following skills:

slow flight
precision flying (turns without altitude loss/
gain, holding a heading and altitude)
no or half flap landings
go arounds
power off approaches
no gps navigation

If instrument rated, take a safety pilot and practice approaches. If you can't devote one hour a week to practicing, try to include some of the above skills as you fly from point A to point B.

If you use the wings program, 3 hours of flying plus the ground webinar/training will count as a flight review.
