


FLYING YOUNG EAGLES

MASTER PILOT AWARD


At the July 15th Chapter Meeting, Chapter Member <u>Duane Seitz</u> was presented with the Wright Brothers Master Pilot Award.

Highlighted emphasis areas to improve situational awareness, fuel managements, decision making, and always have a plan B option when the original plan does not pan out for whatever reason, weather, mechanical, fatigue, etc.

The airspace discussion was a good refresher for those who have not looked at it in a while including different types, equipment & weather requirements, legal ramifications, and procedures for safe operations.

A TRAVEL AIR UPDATE

JAY VIEAUX'S TRAVEL AIR REPLICA PROJECT:

After our August 19th Chapter Meeting, some of the attendees went to Jay's hangar to get a current update on his project. Jay indicated that he had to create pretty much from "scratch", most of the components of the aircraft since parts were not available. Jay furthermore indicates the following:

The Travel Air <u>replica</u> is being built with original drawings obtained from the Smithsonian. According to Jay, this is a "replica", not a restoration, unless he can obtain at least one original part.

The plane was built in 1929 for the biplane class of air racers, to fly from Portland, OR, to Cleveland, OH. It placed 4th, being flown by <u>Harri Emery</u>. The economic depression caused liquidation of the Travel Air company assets, and the racer was sold as a sport plane to Doug Davis, a famous flier of that era.

The wings are wood and have an NACA 23012 airfoil section, (as did many racers of that time period).

THE BUILDER'S CORNER


JOE'S CIRELLI'S RV PROJECT UPDATE:

The Van's build was delayed for most of the summer. In January of 2022, Vans began using lasers to cut their parts. The goal was to increase production of parts to keep up with increasing demand from kit sales. Previously, the parts were CNC punched. Switching to a laser cutting operation could increase production throughput by about 300%. Van's assured its customers that switching to laser cut parts would not degrade quality, and referenced accelerated life testing that was performed in-house. According to Van's, the expected lifespan of laser cut parts was about the same as the CNC punched parts, with airframe expected life exceeding 30,000 flight hours.

Back in the spring, as we were about to begin assembling the prepared parts of the fuel tank, I received notification from Vans that we should "pause" the build due to problems discovered with their laser cut parts. Builders had begun reporting cracking around the holes of the laser cut parts, particularly in the holes that required dimpling and riveting. Unfortunately, it's been a wait-and-see situation, as Vans awaits the results of a third-party testing firm, in-house testing, and various engineering analysis.

For my project, the worst-case scenario will be rebuilding of the wings. While this would set me back quite a few months, it wouldn't be the end of the world. In the meantime, Ed Punjak and I have begun assembling the tail cone (manufactured before the laser cut parts). When that is completed, we'll begin on the fuselage. The fuselage was delivered shortly after Oshkosh this year, with the laser cut parts removed and replaced with the traditional CNC punched parts. There is a couple of years' worth of work before we have to go back to the wings and address the issues with them.

By the time we get back to the wings, I expect that Vans will have plenty of real-world experience and direction on how to remove/replace (or not) the laser cut parts of the wing (primarily the wing ribs).
