Clint brought his flatbed trailer which would accommodate the width of the gear—axle nut to axle nut is 82"--many of the utility trailers are too narrow. We had about an inch clearance on each side. Clint and Joe both know what to watch for while loading and securing a plane. Clint's trailer had an electric wench, so we tied onto the gear and slowly winched the fuse up the ramps onto the trailer, then secured it with ratchet straps. We made the 22 mile trek without incident, then unloaded and moved the fuse into the hangar. Many thanks to Clint and Joe for all their help and expertise—very evident this was not their first time to move an airplane! I also appreciate the thoughtfulness of the other Chapter members who offered their trailers for the move.

Earlier this week, the FAA has released the new rules for the 3<sup>rd</sup> class medical. I read through the new regulation; however, I'm holding comment until I better understand it. The rules are going in effect May 1 2017. If you had a medical exam in the last 10 years from July 15 2016 (i.e.—10 years prior) and your medical hasn't been revoked or suspended, you won't need to go to an AME for a 3<sup>rd</sup> class medical any more.
