When he fired up the burners, John offered to roast marshmallows and wieners. The heat could be felt for about 20 feet around the basket and the flames shot upward in the air about 10 to 20 feet. EAA323 Young Eagles event rescheduled due to weather.

Although there was a great turnout for the event, the weather just didn't seem to want to cooperate. There was a huge turnout in numbers of Young Eagles, Pilots and Ground crew to assist. We also had reporters from KTEN and the Herald-Democrat on hand. And to top that off, we even had coffee and donuts for those who wanted them.

The event has been rescheduled to October 27 at 10am. All those who can show up to help us with this event are welcomed! All Pilots and Ground crew are requested to be at the terminal by 930am.

EAA's Youth Protection Policy and Program sets basic requirements for EAA staff and volunteers who work with children under age 18. It includes online best-practices training and, for certain categories of volunteers, a basic background check (U.S. and Canadian residents only).

All of the following persons are required to complete both the online training and background check prior to the next event! Both steps are necessary and the cost is covered by EAA.

- All Young Eagles pilots
- All Chapter 323 Young Eagles Coordinators and Field Representatives
- Two-deep leadership supervisors
- Volunteers who will work with youth in ongoing programs other than Young Eagles
- EAA staff

Weather cancels free flights for youngsters at NTRA By: Jerrie Whiteley, Herald Democrat

The thick gray fog hanging over North Texas Regional Airport — Perrin Field Saturday morning left an aviation event ground. The Young Eagles Flights sponsored by the Experimental Aircraft of Association that was scheduled to start at 7:30 a.m. never got of the ground. But organizers say not to worry; they will come back around again and hope for better weather.

Young Eagles Coordinator John Horn said more than 2,000 local youngsters have received free flights out of NTRA since the program began. Launched in 1992, the program is aimed at introducing children to the world of flight.

"We do that by pilots volunteering their time and their aircraft, and we have rallies several times during the year when we invite children from the ages of eight to 17 to come out for a free discovery flight," Horn said.

No reschedule has been announced yet, but Horn said there are several such events at NTRA each year. They had planned to take up at least 25 children with seven aircraft. "It's about a 30-minute flight for each group," he said.

Before the planes take off, the pilot goes through a checklist with his passengers. Then once inside the plane, Horn said, the passengers each get a headset that connects the pilot communicate with them so he can explain what he is doing as he is flying the plane.

"And the lucky child who gets to sit in the co-pilot chair very often gets to control the plane for a bit," Horn said.

Two youngsters who showed up to take the rides Saturday were from Bonham. John Trubey, 13, has been up twice. He said he was really looking forward to going up again. "I really like looking down at all of the scenery. It is one of those Hobby Lobby miniatures," he said. The first time he went up was cloudy and the second time was better, he said.

His brother Daniel said he liked getting to fly the airplane while he was up in the sky, but he is not looking toward aviation as a career.

Their mother, Myrna Trubey, said she thinks it is important for America to stay competitive with the world in technology and aviation and one way to do that is to keep children interested in it. She was in the U.S. Air Force and found the rides online. She said right now neither of them is interested in aviation but that doesn't mean they might not be in the future.

Eagle Flights

What do all Young Eagles have? Eagles (aka Parents)! EAA has dusted off their old flight program for Adults and is promoting Eagle Flights. These will be somewhat more structured than Young Eagle events in that adults can make arrangements individually with the EAA Eagle Coordinator, John Hunt.

EAA's Eagle Flights[®] is a free introductory flight experience and informal mentoring program designed to welcome and encourage adults who want to discover flying, but don't know how or where to take that first step. It begins with a hands-on introduction, where you'll fly with a local EAA-member pilot who will let you follow along at the controls of the airplane to get a feel for what being a pilot is all about.

After the flight, Your Pilot can help you learn more about how to get involved in your local aviation community, including the next steps you can take on the path to becoming a pilot yourself.

The best part? The whole experience is free. No sales. No pressure. Just a whole lot of fun and education with a big take-home point: Your dream of flying is a lot closer than you think.


LSA Weight Limit Increasing To 3600 Pounds (Updated)

A high ranking FAA source has confirmed that the FAA plans to almost triple the maximum weight for most Light Sport Aircraft to 3600 pounds in rulemaking that will be introduced in January. The source confirmed the scant details of a Facebook post written by AOPA Senior VP of Media and Outreach Tom Haines from the AOPA Regional Fly-In at Carbondale, Illinois. "Great news out of AOPA: your freedom to fly Fly-in at Carbondale," Haines wrote. "In January the FAA will issue a notice of proposed rulemaking increasing max weight for a light sport airplane from 1320 lbs to 3600 lbs. And ADS-B rebate will be back again in a few days. More to come." The FAA source declined to elaborate on details of the proposed rulemaking but suggested more information will be forthcoming "soon."

EAA Chairman Jack Pelton <u>announced at AirVenture</u> in July the FAA was planning a weight increase for the class of aircraft, which is now set at 1320 pounds for wheeled aircraft and 1430 pounds for seaplanes. Some designs, like the Icon A5, have been granted weight exemptions to accommodate safety features and equipment. The new limit will capture a wide range of aircraft that now require a minimum of a private pilot certificate to fly. What's not clear is precisely how the rulemaking will alter performance limits, passenger loads and weather requirements for LSA operations. <u>AOPA reported</u> EAA Chairman Jack Pelton told the Carbondale event that the new rule "will allow you to fly in a 172, have four seats in the airplane, and fly 150 mph." He also said there were plans to allow professional builders to assemble homebuilts.


Member Bio of the month: John Horn
