

EAA TEXAS FLY-IN CANCELLED FOR 2008

Stan Shannon, Chairman and CEO of the Southwest Regional Fly-In, Inc., also known as the EAA Texas Fly-In, announced that the officers and directors of the SWRFI voted to cancel the fly-in scheduled for October 10-11, 2008 and to ultimately cease operations.

The board made this decision as a result of the following:

- 1. EAA headquarters decided to cease branding regional fly-ins as EAA events.
- EAA will no longer insure regional events.
- 3. Dwindling attendance numbers
- 4. Fewer volunteers

The board felt that losing the EAA brand would make it increasingly difficult to obtain sponsors, exhibitors, and volunteers.

The SWRFI, debt free and in sound financial condition, will support youth in aviation. The board of directors voted to create a youth scholarship fund. Scholarships will assist deserving young men and women in attending aviation related educational programs. Chapters will be notified of the scholarship application process in the coming months. In addition, the SWRFI sponsored EAA Young Eagles, Hondo Aviation Day, will continue as planned and is scheduled for March 15, 2008.

As the direction of the SWRFI changes, and as an exciting 46-year aviation era ends, we look back with gratitude to Tony Bingelis who founded the fly-in, Paul Poberenzy who founded EAA, the many chapters, dedicated EAA volunteers, sponsors and the exhibitors who made this fly-in possible. EAA Chapter 35 has been a mainstay in this event, especially after the move to Hondo, and the leadership of SWRFI is grateful for your collective efforts.



A PIETENPOL IS THE LIFE FOR ME!

I'm going to relate my story here for the benefit of those who might be on the fence.

I was 5+ years in building my first homebuilt, a single-place, VW powered high-winger called the M-19 "Flying Squirrel". I realized my flying skills were going by the wayside as my project dragged on and I was looking up at airplanes flying by a whole lot more than I was actually flying. I was also a few years away from completing the Squirrel. I needed to fly and nothing seemed affordable.

I got very interested in the Pietenpol for its simplicity, 2-place capability, proven design, excellent support, and long history. Starting a second project was out of the question; that would just put flying further out of reach. One day a newly-completed Piet became available, test hours flown off, but took my breath away with a \$15,000 price tag. Time to think about things.

- 1. There is no other complete, new, 2-place, flying aircraft that I want to fly that is available for that price.
- 2. Neither of the two cars in my garage (one is 8 years old, one is not even 2) cost that little.
- 3. Our son owns an offshore fishing boat, twin outboard, that cost more than twice that.
- 4. Pick up any aviation magazine and look for airplanes that can be built and flown for anything less. Not ultralights; REAL aircraft, honest 2-place aircraft.
- 5. See (1.) above. Write a couple of checks to Corky and let's go flying.

The point is that you're not going to get into the air in anything as sturdy, as clean, as fun, as honest as a Pietenpol for anything near the cost of one so why go looking. Look at the EAA "Wood Book" and read the piece that is titled something like, "Why Not Build a Wooden Airplane?" by Tony Bingelis and look at the 3 simplest wood aircraft that he lists. The Volksplane, the Flybaby, and the

Pietenpol. Only the Piet is a 2-place high-winger, and the other two designs are veritable toddlers compared to the Piet design that has been proven since the 1930s.

End of lecture. Build or buy a Piet and start enjoying flying as it was meant to be! I fly as a Sport Pilot, day VFR only, and sleep well at night after falling asleep dreaming about that next flight. You can too...

RON O'DEA — MEMBERSHIP CHAIRMAN



After spending two enlistments in the Air Force, one as a Canine Handler in the Security Police and the other as a Radar Technician maintaining Ground Control Approach Radar (GCA), I started my aviation career by using my GI Benefits to get my pilots ratings. I followed the usual course of attaining Commercial, Instrument and then Multi-Engine ratings and flew as a co-pilot on charter and freight flights while working on my CFI/CFII/MEI. I built my time flying charter and flight instructing and then was hired as Chief Flight Instructor and Manager of another flight school. This was a Cessna Pilot Center and led to my being recruited by Cessna Aircraft Company as a Flight Training Specialist. Because of my additional ratings I was also assigned as Zone Training and Safety Pilot, training new hires on the various Cessna Models and instructing in proper demonstration techniques. This career lasted from 1975 until 1986 when Cessna closed the Propeller Aircraft Division and I had to get real job! During that time I advanced to District Sales Manager, Business Development Manager, and Propjet Sales Manager.

After Cessna I tried various positions and ended up back in aviation with a company called Aircraft Technical Publishers (ATP). This is where I got involved with the maintenance side of our business. ATP produces and maintains Regulatory and Aircraft Maintenance Libraries on all general aviation aircraft. These libraries are provided to FBO's and aircraft maintainers on a subscription basis. My job as Regional Sales Manager was to call on all the aircraft maintenance providers from Colorado to Illinois and Minnesota to Texas. This is when I purchased my first airplane, a 1968 V35A Bonanza. When not selling and teaching the use of the libraries I was teaching "Researching Regulatory Information" to Aircraft Mechanics with Inspection Authorization. This taught me a great deal about aircraft maintenance records and record keeping.

Last year I retired from ATP and my Bonanza has become a Citabria (7GCBC). So, I sit here with an ATP rating and CFI/CFII/MEI ratings and 10,000 hours, with plenty of time to do anything I want and to hang out with my bud's at Chapter 35.


Fred Pennell 1931-2008


Fred, as usual, smiling. Here he's just received a Certificate of Appreciation for his help with the Young Eagles Program.
