Chapter \$500 Scholarship Awarded

The Scholarship Committee, consisting of Ken Hughes, Raenel Gibson and Scott Kennedy has completed its work for the Spring scholarship and awarded it to Cadet Commander Garrett Thomas of the Licking County Composite Squadron of the Civil Air Patrol. Twenty-Two year old Thomas has been a member of the CAP for 8.5 years and has assisted Chapter 402 in many Young Eagles and Pancake Breakfast events over those years. According to the committee members, Thomas met 98% of the qualification requirements for the award, only losing points because he is not a

member of EAA 402. Someone observed that maybe that's our fault!

Thomas already has his Private Pilot certificate. and has approximately 140 hours logged. He is working on instrument rating and 25 hours instrument training and 42 hours of the crosscountry requirements done. He is getting his training through the CAP with a CAP pilotinstructor and plane. He thanked the chapter the scholarship for award and said it would allow him to afford 5 additional hours

Minutes of EAA 402 Meeting of March 15, 2022

The regular meeting, held in the clubhouse, was called to order by President Bernie Volpe who opened the meeting with the Pledge of Allegiance to the Flag at 1900 hrs. The members present were Rollie Bailey, Dan Glaze, Robert Marriott, Bernie Volpe, Tony and Linda Rowell and their daughters Ava and Lila, Raenel Gibson, George Fackler, Greg Kays, Dick Perdue, Scott Kennedy, Dave Clum, Bill Corban, Tom Thompson, Ken Hughes, Ralph Brandon, Bruce Lane, Leota Lane and visitors Jim Lemley and Garrett Thomas. Jim Lemley subsequently re-joined the chapter.

Secretary Report: The secretary asked for approval of the February minutes as printed in the March newsletter. Motion to approve was made by Rollie Bailey and seconded by Ralph Brandon. The motion passed.

Treasurer's Report: Scott Kennedy, chapter treasurer, gave the financial report dated March 15, 2022. This report covered the period from 12/01/2021 to 01/15/2022. The starting balance was \$4913.75. Income over the period, shown on the report as Net Bank Deposits, was \$1768.00. This included Christmas dinner deposits. Expenses over the period was \$2700.57 including utility payments for three months (\$405.77), chapter dues to EAA (\$608), Christmas dinner expenses (\$1478.95) and other. Ending balance is \$3981.21 including a total of \$1876.68 in reserves leaving \$2104.53 in discretionary funds. Motion to accept the report was made by Tom McFadden, seconded by Ken Hughes and passed by the members.

Airport Board Report: Bill Corban gave the report from the last board meeting.

- The engineers presented information about the new terminal building construction. Three bids were received: \$2.7Mil, \$2.95Mil and \$3.5Mil, including construction of the new parking lot. No bid has been accepted but the engineers feel these bids are within reason.
- A grant of \$260,000 has been received for paving upgrade of the runway. American Pavement will be doing the work.
- The new T-hangar row has minor work to be done. Water is getting into the
 concrete block fire wall making the wall wet but not getting into the hangars
 otherwise. Freeze and thaw cycles could be a problem but this can be fixed
 easily.
- Aviation Works has moved ahead with renting the new hangars and backfilling the old ones vacated by renters moving from old to new and most of the hangars are already rented. George Fackler answered questions about the rental rate and said there are three numbers smaller hangars are \$265/mo, next larger hangars are \$300/mo and the largest are \$375/mo. The 50X50 box hangar is \$1000/mo. There was discussion about lack of auto parking for the new hangar row and loss of parking for the west side of the existing hangar row. George said he is very concerned about this. He doesn't want to see any cars or planes damaged by props throwing rocks.

Old Business:

 Ray Aviation Scholarship: Scott Kennedy reported that the EAA has approved EAA402 for a 2022 Ray Aviation Scholarship (Please refer to the March newsletter for the letter of approval. Secretary). Scott said we are now in the selection phase and need names of candidates. Some discussion and clarification followed from Scott and Tom.

- \$500 Chapter Scholarship: Ken Hughes reported that the committee has reviewed the application, interviewed the candidate and made their selection. The selectee, Garrett Thomas was present at the meeting, was introduced by Ken and spoke for several minutes. Garrett is twenty-two years old and has been active in the CAP for eight years as they assisted EAA402 in many Young Eagles and pancake breakfast events. He has his private pilot certificate and about 150 hours in his logbook already. Garrett thanked the chapter for the \$500 and said the money will give him five more hours of instrument training which he gets through the CAP. Raenel Gibson, a member of the scholarship committee said, as a point of order, a vote is required to accept the candidate. Motion to accept this candidate for our \$500 scholarship was made by Dan Glaze, seconded by Linda Rowell and passed by the members.
- Learn to Fly Day/Eagle Flights: Ken reported that he has three signed up for the event of May 21st. Ken reported that the EAA has provided him with two tickets to Airventure 2022 to award to "students" that day. Ken has several pilots and other volunteers signed up to help out at the event. Tony and Linda Rowell volunteered to help at the event.

New Business:

443 Young Eagles Trailer: Ken Hughes reported that Chapter 443 of Lancaster/ Fairfield County Airport has a 6X8 ft enclosed trailer the originally used for Young Eagles but are no longer using and are offering to us. Money has not been mentioned so we don't know if they want to sell of give it to someone. There was interest in the trailer and discussion about getting it. Several members questioned the wisdom of having such a trailer. Among those were Bill Corban, Tom McFadden and Bernie Volpe. All three suggested we are doing well with our present setup and don't need such a trailer. Several relevant questions asked were: Where would it be kept? Who would be responsible for it? Why do we need it? After all discussion, it was decided that Ken Hughes and Tom Thompson would go to the Fairfield County airport, look at the trailer and report back about its condition.

Announcements: The secretary announced that, at his request, Tom Thompson has completed an application to become a Technical Counselor for the chapter. President Volpe has signed the application as required by EAA. The secretary will send the application forward to EAA Safety Programs office.

The meeting was adjourned by the president at approximately 1950.
