Old Business

- **Approval of Minutes** – Approved minutes are uploaded to the website in a library at the bottom of the site under “Chapter Misc – Meeting Minutes”.
- **J3 Cub Donation** – An Auxiliary Board Meeting was called on August 2, to act on the recommendations of the J3 Donation Committee. The meeting was held via emails. The Board approved Judi’s motion that we NOT accept the donation.
- **EAA Build and Fly Program**
 - The proposed starting date for the program is Saturday, October 21. The program would run for 6 to 7 weeks with each session lasting 3 hours.
 - Jim Vonderwerth, Dale Kral, & Jim Wilson will oversee the program.
- **Adopt-A-Highway**
 - July 15 cleanup was a success, with 9 participants.
 - CalTrans has paid the Chapter \$4000, through June 2023.
- **AirVenture** – Over 20 chapter members attended AirVenture this year.
- **Pancake Breakfast**
 - August 5 Pancake Breakfast – served 159 meals. \$1136 breakfast sales, \$158 donations, \$54 recycling, \$20 gear, \$17 name tags; \$1385 total

New Business

- **Upcoming Events**
 - 8/16/23 – General Chapter Meeting. FAA NorCal speaker, Steve may speak, but he has not yet confirmed. As a fallback, we will ask chapter members that attended Oshkosh to describe their experiences.
 - 8/19/23 – Adopt-A-Highway. Due to the heat, we will meet at 7:30 AM at McDonald’s in Cameron Park and plan on being done by 10:00.
 - 8/27/23 – 2nd Annual Fly-In Breakfast Burritos. Gordon hangar, 8-11 AM, \$8 adults, \$4 kids, plan for 150 attendees. Need assistance transporting tables and chairs from the EAA hanger to Gordon’s.
 - 9/2/23 – Pancake Breakfast
 - 9/20/23 – General Chapter Meeting
 - 10/14/23 – Young Eagles
 - Event registration opened on August 1. Filled up withing 2 hours.

o **Chapter Officer Election**

- o Judi and Rob volunteered for the nominating committee.
- o Judi will ask Beki Parks if she would also participate on the nominating committee.
- o Nominating committee will approach members to see **who you** is willing to be on our Board.
- o The slate of candidates needs to be published by the October General Meeting.
- o The Election will be held in November, via Mail Chimp.

o **Cleco Challenge**

- o At Airventure, Glenn Gordon achieved the “World’s Fastest Clecoer” award for inserting and removing 10 clecos in 28.9 seconds. Glenn proposes having a similar activity for our EAA activities.
- o We would need: Aluminum tube mounted on an oak base with rubber feet, 10 clecos, pliers, cleco cup, and stopwatch, instruction and time board, & possibly buttons. Cost of materials is estimated at \$95.
- o A motion was made, seconded, and approved to create this activity and test its popularity.

o **Pancake Toppings**

- o An informal poll taken at the Aug 5th pancake breakfast indicated that 72% attendees would like the option of a fruit topping such as strawberries or blueberries for their pancakes, and would be willing to pay an extra dollar for this.
- o Judi/Glenn can get a 7.5 lb container of Sliced Strawberry topping, and 2oz souffle cups with lids from Restaurant Depot to make individual containers for sale. Judi will fill containers and bring to the pancake breakfast.
- o Judi would like net proceeds to go to Sunny Atkins Scholarship fund and will track in monthly reporting.
- o The extra \$1 charge will be collected near the Fruit Cup Station so that the cost does not affect donations at the start of the pancake line.
