Meeting called to order at 7:05PM by President Jim Suggs. Andrea Muller-Hoff read the minutes of the previous meeting. Stephen Thomas clarified that he left lord mounts and electric parts at the hangar, and has wheels, tires, and prop extensions at home, for members who could use them. Upon motion of Brian Jones, second by Stephen Thomas, and vote, the minutes were approved as corrected.

John Flanagan presented the Treasurer's Report:

Hovercraft update: The group is working on mounting the lift engine, a Briggs & Stratton 6 HP lawn mower engine that has a 3 bolt mount.

New members, hangar access requests: Paul Chappius has requested a hangar badge, for access as a member of the flying club. Following discussion, Jim Suggs made a motion to approve Paul Chappius for a badge, and key to the west door. Second by Brian Jones, and upon vote, the motion was carried.

2019 Events:

Review of August 11th Car Show: due to a poor showing, John Flanagan stated that he would not organize another car show. Following comments, Jim Suggs recommended that the event not be repeated.

Jim Suggs reported that the local Civil Air Patrol has requested that EAA 533 fly 6-8 Cadets on Saturday September 21st. Lou Kossler volunteered to fly the Cadets.

Jim Suggs will be there, with the event starting at 10:00AM, providing there is no fog.

Ongoing Chapter Project! We are constructing a **UH-12T4 Hovercraft!** This new


