Meeting called to order at 6:07 PM by President Brian Jones. Minutes of the previous meeting were read by Dick Welles. Upon motion of Mike Depue, second by Dick Welles, and vote, the minutes were approved as read.

Treasurer's Report:

John Flanagan presented the Treasurer's Report:

Dick Welles, Scholarship Coordinator, reported on the Ray Scholarship Chapter Application. 169 applications were received at National. 128 scholarships were given out.
