Drone Safety Day returns in April



Drones are the fastest growing segment of aviation in the United States. As of January 2023, there were over 871,000 drones registered with the FAA, and over 307,000 certified Remote Pilots. These numbers are projected to continue to grow and we want everyone who operates drones to have fun and be safe!

Drone Safety Day (DSD) is an annual campaign dedicated to educating the drone community of the importance of flying safely. DSD will highlight the societal, economic, and safety benefits of safe drone operations with in-person, virtual, and hybrid events in focus areas such as **Education**, **Economics**, **Equity**, **Environment**, and **Emergencies**.

Download the <u>2023 Drone Safety Day Playbook</u> and <u>2023 Drone Safety Day Flyer</u> to learn more on how you can participate. These materials will give you an outline of what Drone Safety Day is all about and ideas for how to put together a DSD event.

The one-day event, slated for April 29, 2023, encourages drone pilots and recreational flyers to "Fly RIGHT" by focusing on five safety elements:

- Have a safety plan
- TRUST and Train

EAA Announces Inaugural Learn to Fly Week – May 15 to 20

Aspiring aviators will have the opportunity to discover multiple pathways to becoming a pilot as EAA presents its inaugural Learn to Fly Week on May 15-20.



Beginning May 15th, expert flight instructors and representatives from various aviation organizations will present free, interactive webinars. These webinars will cover topics from starting flight training, saving time and money in flight training, preparing for the FAA written exam, to passing the checkride, and so much more. While the live showing of these presentations will be open to the public, the recordings will be archived for EAA members to view at their convenience.

Learn to Fly Week will conclude on Saturday, May 20, with Flying Start events hosted at chapters across the country. EAA's Flying Start program allows EAA chapters to welcome, encourage, and educate new aviation enthusiasts about the fun, freedom, and accessibility of personal aviation in their local area. Following a short presentation about learning to fly, attendees will be offered a free introductory Eagle Flight to experience the spirit of aviation firsthand.

"Becoming a pilot is a dream for many, but few know where to start their journey. Learn to Fly Week was created to help encourage aspiring pilots to take action and begin the pilot training process," said David Leiting, EAA Eagles Program Manager. "Our goal is to show attendees how accessible achieving their dream actually is." Leiting also added that inspiration from this event stemmed from packed forums at the Learn to Fly Center at EAA AirVenture Oshkosh 2022, as well as the success of other EAA virtual events like Homebuilders Week and Virtual Ultralight Days.

Combining the educational forums from the Learn to Fly Center and the connections and inspiration found at Flying Start events, EAA Learn to Fly Week is the latest effort in the ongoing effort to help aspiring pilots achieve their dream of flight.

Phil Washington Withdraws from FAA Administrator Consideration



Phil Washington, the CEO of Denver International Airport and embattled nominee to become the next FAA Administrator, has withdrawn from consideration, U.S. Transportation Secretary Pete Buttigleg confirmed on Saturday evening. Buttigleg released a statement on Twitter saying, "The FAA needs a confirmed Administrator, and Phil Washington's transportation and military experience made him an excellent nominee. The partisan attacks and procedural obstruction he has faced are undeserved but I respect his decision to withdraw and am grateful for his service."

The White House initially nominated Washington to the post in July. At the time, he had been CEO of the airport for six months but brought years of transportation experience as the CEO of the Los Angeles County Metropolitan Transportation Authority and of the Denver Regional Transportation District. He also spent 24 years in the U.S. Army and led Biden's transportation transition team after he won the presidential election.

However, Republicans in both the Senate and the House raised objections over his experience, saying the FAA is facing numerous challenges that required a person with a strong aviation background. Sen. Ted Cruz (R-Texas), the ranking Republican on the Senate Commerce Committee, led the objections calling him the wrong person for the job.

Also clouding the nomination was a corruption probe ongoing stemming from Washington's time as CEO of the Los Angeles County Metropolitan Transportation Authority. The California Attorney General's office confirmed to Cruz that Washington was a "material" part of this probe.

While the Biden Administration initially nominated Washington in July, the Senate failed to act on it before that previous Congress concluded, oftentimes a sign that a nomination would whither away. Biden, however, resurrected the nomination in January when the new Congress took office.

Following the recent notam system meltdown and aircraft close calls that were making headlines, Senate Majority Leader Chuck Schumer (D-New York) called for action, saying: "It's time to clear the runway for President Biden's choice for FAA Administrator, Phil Washington."

Senate Commerce Committee Chair Maria Cantwell (D-Washington) offered strong support citing his background in transportation and her office released numerous letters of endorsement from unions, airport groups, airlines, and from past FAA administrators—who like Washington had limited aviation experience when they stepped into the role of leading the agency.

While the Commerce Committee held a hearing in February and scheduled a vote on the nomination this past Wednesday, signs of trouble of its ultimate fate arose when Cantwell delayed that consideration at the last minute, saying there would be a "future date pending information that members have been seeking." While she did not elaborate on what information or which members were seeking it, she also stressed, "We will have this debate in the future."

However, it had become unclear whether the votes were present to push through the nomination. In addition to Republican opposition, Senate Commerce Committee members Kyrsten Sinema (I-Arizona) and Jon Tester (D-Montana) reportedly appeared uncertain on the nomination.

Alongside the opposition in the Senate, the nomination was receiving objections in the House. House Transportation and Infrastructure Committee Chair Sam Graves (R-Missouri) had said Washington required a waiver from a provision requiring that the FAA Administrator be a civilian. Graves suggested the House would not provide such a waiver.

Meanwhile, Cruz has offered acting Administrator Billy Nolen as an alternative nominee saying such a prospect would have a "clear and easy path" to confirmation with bipartisan support.




February's Question:

Here is your stumper for February, Name this plane. If you can name it, can you tell me some of what it helped to pioneer, aeronautically speaking?

February's Answer:

This large twin is none other than a 1929 Consolidated "Commodore", Model 16. The Commodore was a forerunner to the era of the large "FLYING BOAT" aircraft that were to pioneer the large cities in




Northern America with those in South America. To provide this service the New York, Rio, Buenos Aires (N.Y.R.B.A.) Air Line was launched in February 1930 with an 8900 mile route. After being Christened by Mrs. Herbert Hoover, the wife of President Hoover, the flagship of the Commodore fleet The "Buenos Aires" embarked with its first full load on July 1929. The flights left Miami bay weekly on a 7 day schedule. The 8 stage flight arrived, weather permitting, in Buenos Aires at least 11 days before the fastest steamship. Early business was very good, but due to money problems, which plagued most of the early lines the company was bought out by Pan American in September 1930. Since the Commodores were designed for long over water flights Pan American started the longest over water flights in the world in 1930 from Jamaica to Panama. The Commodores continued on until late 1935. the plane had a crew of 3 and seating for 18 to 22. They cruised at over 100 mph with a range in excess of 1000 miles, over water. These birds were the first big planes built by Consolidated Aircraft and were the direct forerunners of the PBY "Catalina" of World War II fame.

And.... We have a Winner!!!

Gerry Visel of EAA Chapter 22 provided the following answer:

The February airplane of the month is a Consolidated Commodore, with Pan Am livery. It lead to the development of long range flying boats, and specifically to the famous PBY Catalina. The only known Model 16 Commodore remaining has been located in a northern Canadian lake. There is currently an ongoing project to raise and restore this airframe for display at the San Diego Air & Space Museum.


