NEWSLETTER QUIZ

Each month, we will ask a "question" in the newsletter. Answers are given at the meeting referenced in the newsletter. At the end of the year, there will be a prize to the person who has the most correct answers. Some will be easy and others not so much.

November Question: You are performing a compression test on a four-cylinder Lycoming O-360 engine and charge a cylinder to 73 psi. What is the total force in pounds on the piston? (This is why compression tests can be dangerous)

November Answer: Bore and stroke values for a Lycoming O-360 engine are 5.125 and 4.375 inches respectively. Piston area is 20.629 square inches. Multiplying the piston area by the pressure in pounds per square inch gives a peak force of approximately 1506 pounds. If the piston is at top dead center, the force will decrease as the piston descends and the volume increases. If the propeller moves accidentally while the piston is at or near top center, it will move with quite a bit of authority.


