The meeting was held in hangar H-21, also known as the home of Rick's Cozy MK-IV. Meeting time is same as usual, 7:00 PM

3 Guests, 3 officers and 4 members attended the open forum meeting.

Two Innovation Center young ladies attend, Masddison and Clare. They both have a strong interest in Aviation and expressed their desire to publish in our chapter newsletter. Maddison is a

talented graphics artist and offered her original aviation art. Clare is talented at aviation photography at Longmont and surrounding airports and offered to have some of her photographs featured in our newsletter. Dan Berry agreed to coordinate with them.

Alex Gustafson reported he has been actively enrolling in EAA Chapter Officer support programs. He started the discussion of the monthly meeting format being changed from a Business section - Program to *Program then Project Reports* and only having a Business Report quarterly.

President Malcom Dean made the motion to change our meeting format to Program-Project Reports and only having a Business Report quarterly.

Member Ed Barens seconded the motion, and all voted in favor.

Meeting discussion continued with having a few active builder hanger visit meetings a year. Dan Berry will leverage his Technical Counselor involvement and work towards this goal.

The group also decided the Chapter Officers will meet quarterly and members are invited. The focus will be upcoming program planning, event planning and financial review. President Malcom Dean took the action to schedule the Quarterly Meetings starting in May 2022.

Chapter membership and Chapter Communications to reach potential new members was discussed. Our current paid membership is now at 17.

Since we are an Experimental Aircraft group, we decided to experiment with adding two parallel communication paths alongside our current Newsletter and EAA website approach.

First we will be experimenting with the addition of a Facebook page. Natalie Gustafson will be doing the design to be reviewed by the officers and then membership for input. The content will be replicated from the newsletter guest speaker, meeting minutes, president message so all messaging is consistent. The newsletter will remain unchanged.

Secondly, we will begin sending a meeting BCC reminder from the chapter email address to the paid 17 members which will hopefully grow. The reminder will be sent after the Newsletter is published and will replicate the content of the Facebook page.

Dan Berry offered to manage and send the monthly reminders. Officer Quarterly meeting reminders will be included in this communication path.

Our experiment is to see if we can grow our audience and membership with the parallel path communications through the Newsletter, Website, Facebook and Email reminder.

During our discussions, Innovation Center guest Maddie expressed many website enhancements and contact improvements to be considered. She also offered to help the chapter with Name Badge design. She will coordinate with Dan on this as well.

Member and Innovation Center volunteer Paul Hollingshead gave a brief report on the Van's Aircraft RV12 that one wing is about ready for final riveting of the skins and closing the wing.

He also mentioned the project will be sold at some point making room for the next project, a Carbon Cub that is on order.




Curios about aircraft projects under construction near you?

- >Move down in the pop up box to EAA Builders Log





EAA 648 Officers Meeting Report

On Saturday, June 4th, the Chapter 648 officers met to discuss what future actions may be necessary to continue operating as an EAA chapter. Currently we have only seventeen paid-up members. Fixed costs owed to EAA national for continuing membership and Chapter insurance require, at a minimum, forty-four paid-up memberships just to break even. It is probably the case that a major effort to solicit memberships to meet our obligations could succeed in keeping us operational for another year, but a far more important question arises:



What's the point in keeping going if there's no true interest in our membership at large? Each of us has to ask ourselves, "What is my interest in being a Chapter 648 EAA member?" What does our Chapter have to offer? "What would I like to see 648 do?" And most importantly, "Am I willing to become involved in helping out?"

Not everyone needs to put a major effort into chapter activities. To succeed a chapter needs members who just show up for meetings and encourage others to do so, members willing to serve a year (12 meetings) as an officer, members who will participate in one or more Chapter activities, and a few willing individuals who will step up when asked to help on a particular
