# Experimental Aircraft Association (EAA) Chapter 857 James C. Ray Flight Training Scholarship General Information CY2024

Congratulations on your decision to apply for our flight training scholarship!

Acquiring a pilot's certificate is a privilege that requires commitment, dedicated study, perseverance, and a willingness to learn. This endeavor should not be taken lightly, but the process will be very rewarding and will, in many ways, change your life.

The Private Pilot Flight Training Scholarship opportunity currently available is for individuals' ages 16 to 19 (at the start of flight training).

The maximum scholarship award amount for the private pilot certificate is \$11,000.

Flight training is tailored to individual abilities. It is possible the private pilot certificate can be completed at a cost below the \$11,000 award limit. *However, it is also possible that training completion may require additional funds to be provided by the applicant.* 

If awarded a scholarship, EAA national will provide funds to EAA Chapter 857 to administer on behalf of the student pilot. Continued funding is dependent upon the scholar completing progress reports and meeting training milestones in a timely manner. The scholar will have **60 days** following award notification to choose a flight training school / instructor and complete the first training flight, **3 months** to complete the first solo, **6 months** to complete the FAA written exam, and **one year** to take the FAA Practical Exam (check ride).

The scholar will commit to a minimum of two volunteer hours per month for the local EAA chapter.

A *Third Class FAA medical certificate* and a *student pilot certificate* are required prior to training. If you are selected for the scholarship, a local EAA member will help you understand and complete these requirements.

It is important to remember that our scholar nominee is not approved for the program until application and final review by EAA National is completed. Our chapter coordinator will assist the selected scholar with their application to EAA National.
