### **Technical Counselor Program**

At the beginning of 2019 I renewed my association with the Technical Counselor (Tech Counselor) program to be available to help our EAA Chapter 857 with aircraft projects and restorations. So what exactly is the Technical Counselor program and why you should take advantage of this valuable resource.

The Technical Counselor program was developed to deal with the mechanical factors that can present potential issues during your first flight in a homebuilt. The saying, "**jack of all trades, but a master of none**" can describe the average homebuilder. No one knows how to do everything and everyone starts as a beginner.

A goal of the program is to utilize the Counselors in a form of an educational task force which will be everready to answer questions or to teach a skill. In this way, the pool of experienced builders and restorers will be continually expanded.

The Technical Counselor program has several goals, an important one is to get a Tech Counselor involved with every airplane being restored or built. This way, regardless of the level of involvement, there would always be an expert who is bringing a fresh point of view to the project. So let us take a look at the objectives of the program.

### Objective One: Increased Airframe and Power-plant Safety

A disproportionate number of serious and fatal accidents occur during first and Phase 1 flight testing, which makes good pre-first flight testing and careful inspections especially important. Most first flight failures result from a system or structural problem that was overlooked by the builder. Even the builder's inspection, taxi testing and ground run-up may have failed to reveal these problems. In many cases an in-depth inspection by a qualified Tech Counselor and a few key system tests, such as a thorough fuel system test, might have revealed these deficiencies before any flight took place. A Tech counselor with expertise in the particular model of aircraft and/or with the particular type of construction can often see things that are not obvious to less experienced individuals. Builders and restorers get so close to their projects for so many years that they don't see all the details that have come together over the life of the project. That's where an extra set of eyes can be invaluable. This concept can help to build long term safety and reliability into the aircraft and eliminate problems further down the road.



### **Objective Two: Builder / Restorer Education**

The global base of experience from which Technical Counselors are selected, represents an enormous pool of knowledge. Under the Tech Counselor program the cycle of having to learn then re-learn a skill will be less of a hinderance.

### **Objective Three: Increased Completion Rate**

The completion rate of aircraft projects has always been challenging. The advent of kit aircraft has greatly increased the success rate, look at Van's RV aircraft flying today! But there are still a number of projects that do not come to fruition.

Although money and available leisure time are undoubtedly at the top of the list when it comes to the decision to sell an incomplete project, there are other issues at hand as well. Some projects are not completed simply because the builder/restorer became bogged down by problems that didn't know how to solve efficiently. If there were a Counselor whom the builder could turn to with questions, the chances of completion would increase significantly. Ideally, the individual will contact the Counselor long before he or she actually starts the project. That way the potential builder / restorer can sit down face to face and discuss the project in realistic terms. By meeting with a counselor ahead of time, they can evaluate their own ability to dedicate time and rise to the many challenges which building an airplane represents.





The Technical Counselor program is available to EAA Chapter 857 members. We have two Counselors and we are ready to help you with your project. Keep on building and "keep'm flying!













# **Buzz Warning**

I stopped by our friendly FSDO to turn in my IA renewal documents and spent time with one of the Inspectors in the office. Our FSDO office is there to help you with both flight and aircraft maintenance issues.

While waiting for visitor credentials to be processed I noticed this pamphlet in the waiting area. I read through it and realized that the non flying public has at their disposal ways to identify low fly airplanes that maybe on a "buzzing mission" over friends houses or gatherings.

The FAA takes any complaint of an alleged violation of a FAR seriously! A violation case will be assigned to a safety inspector and he will be asking questions. A lot of questions.

So let us review FAR 91.119. It says, "Sec. 91.119 Minimum safe altitudes: General. Except when necessary for takeoff or landing, no person may operate an aircraft below the following altitudes: (a) Anywhere. An altitude allowing, if a power unit fails, an emergency landing without undue hazard tp persons or property on the surface. (b) Over congested areas. Over any congested area of a city, town, or settlement, or over any open air assembly of persons, an altitude of 1,000 feet above the highest obstacle within a horizontal radius of 2,000 feet of the aircraft. (c) Over other than congested areas. An altitude of 500 feet above the surface, except over open water or sparsely populated areas. In those cases, the aircraft may not be operated closer than 500 feet to any person, vessel,



vehicle, or structure. (d) Helicopters. Helicopters may be operated at less than the minimums prescribed in paragraph (b) or (c) of this section if the operation is conducted without hazard to persons or property on the surface. In addition, each person operating a helicopter shall comply with any routes or altitudes specifically prescribed for helicopters by the Administrator.

Bottom line is, people are watching and with smartphones you could be recorded and now you have the "carpet dance" with the FAA safety inspector.

You worked hard to get your pilots license so don't do something to jeopardize loosing it. Enough said. Stay safe.

# Oshkosh Bus Trip 2019 / 30th Anniversary


