Chapter Chatter



Dennis Lord is our current Chapter 96 President, executive producer of the <u>EAA 96 Fly-In and Model Expo</u>, and a member of the LA County Aviation Commission overseeing five County airports including Compton.

The Expo is coming and we need volunteers. Keith Spreuer is the volunteer coordinator and he would like to hear from you. Bill Kealey has secured our event radios after a minor glitch due to a change of ownership at the radio shop but we worked past that. David Gee is back to manage glider ops in the hangar and his volunteers from last year are secured. The model clubs are confirmed and will have a good presence. Our show open patriotic tribute is confirmed. Attendees all comment on how much they love to see the banner ops. Still, we need some more volunteers for Friday setup and early arrivals on Saturday. This is the only general fund fundraiser that we do and if you care about your Chapter, we would appreciate your support.

At Saturday's Member's meeting (9/16), I hope to see a solid proposed slate for incoming Directors and Officers. We are losing one Director seat and need to replace it. In the change with Dustin leaving for Air Force flight training, his void will be filled by Chris Lord and Kyle Hathaway from LA Air Force Base who have agreed to share responsibilities. This team approach seems to be working so that one individual does not have to do all the work. Due to the Expo, there will not be a Young Eagles rally this month but will resume in late October.

The Internet "deal" that was proposed last month did not materialize at the price quoted. Therefore, no progress. We simply cannot seem to break down the barriers to making this happen primarily due to the reality that funding simply isn't in place. While speaking to funds, it was noted by me that standard hangar reassessments on the airport resulted in a 160% increase in Possessory Interest Taxes paid on their monthly bill. In speaking briefly with the County this week, I expressed my concern that should such an increase occur on the EAA leasehold, it would nearly break us. I was told, and we'll know for sure when the invoice comes around October 1, that our leasehold is already invoiced by the Assessor and that there should be no corresponding increase. Hopefully, that is truth.

On the plus side, we have found a way to replace our worn out air conditioners in the Conference Room, Kitchen, and the Office space. All funded externally to our organization. Let cooler heads prevail!

I am hearing that the runway/taxiway reconstruction process will commence in October. At the recent Commission meeting at CPM, my takeaway was that operations will not be affected except for that period that 25L is being worked on. Due to regulations that prohibit night landings upon unlit runways, night operations will be prohibited by NOTAM for that period of time to restore 25L which is the only lit runway.

In a time when airports should be promoted, I learned today that yet another aviation event has gone West, and one we participated in. Wings, Wheels, and Rotors at Los Alamitos JFTB has folded its tent. The Base's Legal Team has taken a position the last three years that there is too much liability to continue flying activity. It has been a trying experience for the Los Alamitos Chamber of Commerce to motivate sponsors and more to support an event that no longer supports flying. You may recall that we (Chapter 96) started flying Young Eagles for them in 2005. After the first three years, I turned it over to Chapter 7 who ran it for seven more years. We would average 200 kids flown each year in a 6-7 hour period! But, those days went away three years ago and with the handwriting on the wall, the Chamber made their announcement today.

In a similar vein is SMO with the AOPA and others now filing legal briefs. While it seems ominous to some in my age bracket, I see a huge shift in aviation to autonomous operations and the needs of someone to maintain those systems. It took my Dad's generation 66 years to go from Kitty Hawk to the moon. We've stumbled in low earth orbit since and now the world of autonomous operations and AI are on our doorstep. What will the coming decades provide?

EAA Chapter 96 is happy to announce a monthly VMC club opportunity for Non-instrument rated active pilots who want to improve their proficiency. This is a new resource through EAA's VMC Club.

The VMC Club is modeled after the popular IMC Club concept which provides organized "hangar flying" focused on building proficiency in instrument flying. The VMC Club will do the same, but for pilots who are not instrument rated and fly primarily under visual flight rules and under VMC.

Chapter 96 is providing monthly VMC Club meetings in which pilots can network and share knowledge and experience. We will use real-world scenarios to engage members, and allow a free exchange of information that improves awareness and skills. 
