Chapter Business

Following are the main agenda points that had been addressed:

2020 Holiday Get-together

It was decided at the meeting that, due to the Covid 19 pandemic, we would forgo this year's holiday dinner and plan instead a spring get-together.

2021 Judges School:

Wayne Buescher, Certified IAC J.S. Instructor, offered to teach the class. We are looking for a late April/May timeframe at a Pontiac (PTK) facility. More details to follow.

2021 Michigan Aerobatic Open

We decided to stay with the weekend after the Fourth of July holiday, which is July 9-11. Thursday is box set-up day, Friday registration and practice, Saturday and Sunday being the competition days. Dan Unger accepted being Contest Director, Hugo will be assistant CD. We would like to fill all volunteer positions as soon as possible, please let Dan know of your preferred assignment.

The Fifth and last Chapter Practice Day this year took place on October 17 at D98. It was another perfect day for this kind of flying event. Unfortunately, two pilots who participated in previous practice days and were planning to practice were unable to attend. Alex Ayers, who is taking instructions in a Great Lakes had a weekend off and visited his home in Pennsylvania and Jason Ledbetter's Bücker Jungmann is undergoing the annual inspection. Hugo practiced the 2020 Unlimited Known in his Staudacher Pitts S-1-E, watch the You Tube video https://youtu.be/9FADxe9cGfo (note, the camera was angled sideways in a way that it distorted the alignment with the X-Y axis. Future practice days:

Chapter 88 will continue in 2021 with a monthly practice day Romeo State A/P (D98). Pending seasonal temperatures, we could start as early as March. Assuming that the restrictions concerning the Covid 19 pandemic have eased by the time of our 2021 contest to safely hold the annual Michigan Aerobatic Open Championship, these practice days are an opportunity for pilots, judges and assistant judges to get ready for the new season and the contest.

Practice Days also provide an opportunity for anyone to fly for a SMOOTH Patch. Reviewing the IAC list of current active Chapter 88 members who have obtained an Achievement Award, there are many of you who could still add a few Smooth Patches to your collection (see chapter website https://chapters.eaa.org/iac88 "Members Flying Awards").

Chapter 88 practice days will be managed in accordance to IAC guidelines. These can be found on the IAC website: https://www.iac.org/chapter-resources

EAA insurance will be applied for each of the practice days. Insurance covers also rain dates, typically the following weekend.

Every pilot participant must obtain a pilot briefing and undergo a **tech inspection and document check**, identical to that when attending an IAC sanctioned contest, prior to flying in the designated waivered airspace. Bring a copy of your sequence for a judge to critique you. For anyone flying for patches, we have copies of the patch forms.
