Other Issues

2023 Michigan Aerobatic Open

In 2023 Chapter 88 will celebrate its 50th anniversary of incorporation as an IAC Chapter. During the August chapter meeting, members present brainstormed on how to increase participation of competitors, judges and volunteers at next year's contest. Laura Buescher reminded the group that hosting the IAC Open Championship East may be a great opportunity to accomplish just that. In order to be considered for hosting the Championship East, the chapter needs to submit a proposal no later than two weeks before the IAC Fall Board Meeting to IAC.

If we are serious about bidding on the Championship East, a bid package needs to be prepared without further delay. Time at next chapter meeting on Sep 17 needs to be dedicated to this task. Anyone having any suggestions, please advise. Bay City Aero Club has already been requested to inquire about the availability of extra hangar space in addition to that in the Dora Hangar.

Aerobatic Practice Area Waiver

Hugo has initiated the renewal of the Certificate of Waiver for the practice box at Romeo State Airport. FSDO acknowledged receipt of request for renewal. Currently awaiting assignment of an inspector who will process the new CoW. Current 3 year CoW expires 2-28-2023.

Next Chapter 88 monthly meeting September 17 – Chapter meeting followed by practice and patch flying, practice judging at Romeo State Airport (D98) starting at 10 am.
