With a number of new aerobatic enthusiasts and volunteers expressing interest in our type of flying and activities, Chapter 88 is planning to host a Judges School during the late April or May timeframe. For new pilots and volunteers getting into aerobatics, attending a Judges School provides a basic introduction to IAC, the Aresti language and the rules and criteria applied when judging aerobatic figures. A follow-up with the Bay City Clerk Office has been made to inquire about the return of the security deposit (Note: Bay City has returned the security deposit since the last meeting).

Contest material that was temporarily secured in Doug Dodge's hangar has been moved into the Chapter Trailer on Sep 22.

#### 2021 Judges School:

Wayne Buescher, Certified IAC J.S. Instructor, offered to teach the class. We are looking for a late April/May timeframe at a Pontiac (PTK) facility. More details to follow.

#### **Chapter 88 Practice / Patch Days**

The chapter has obtained a 3 year, long term aerobatic practice area (LT-APA) Certificate of Waiver for Romeo State Airport – D98. Plans are to hold a monthly Practice Day on the 3<sup>rd</sup> Saturday of the month from 10:00 to 16:00:



#### **Future practice days:**

October 17 at Romeo State A/P (D98), EAA insurance policy has been received



Chapter 88 practice days will be managed in accordance to IAC guidelines. These can be found on the IAC website: https://www.iac.org/chapter-resources

EAA insurance will be applied for each of the practice days. Insurance covers also rain dates, typically the following weekend.

Every pilot participant must obtain a pilot briefing and undergo a **tech inspection and document check**, identical to that when attending an IAC sanctioned contest, prior to flying in the designated waivered airspace.

Bring a copy of your sequence for a judge to critique you. For anyone flying for patches, we have copies of the patch forms.

If anyone of you competitors wish to use the APA any time other than the monthly practice session, please contact Hugo, he will arrange for the APA to be activated and will be on site to serve as the ground observer.
