## **March Chapter Meeting Key-Notes**

The March meeting took place at James Clements A/P in Bay City.

Valley Aero Club present: Chuck Binder, Charlie Smith

Main discussions focused on the preparation for the annual aerobatic championship:

Special Event Permit: A draft received from the city stated in section "other Conditions/ Requirements" that no overnight camping on airport property is permitted. This condition has been added by the City as a new item this year. Chuck Binder, President of VAC, took on the assignment to consult with City Officials about allowing a minimum number of campers (without the need to apply for a permit) on the airport property during the contest days. Due to Chuck's time and efforts, the airport camping issue with the City has been successfully resolved. On April 3, the City issued a revised permit allowing a maximum of 4 campers overnight at the airport property. Thank you, Chuck.

#### Meeting Key-Notes, cont.

- There are some 632 trash bins stored in the Dora hangar. Chuck Binder checked with City Officials and was told that they will be moved to the city maintenance building.
- Sponsorship Drive in progress, most of the traditional sponsors have so far signed up.
- Contest shirts have been received, everyone present at the meeting loved the color combination of the shirt and special anniversary logo.


