    - A. Created a possible form to be used

  - ii. Publicizing non chapter aviation events
    - A. Low n Slow: Will add a blurb in newsletter, promote at Gathering, will share the story in IG multiple times: Registration link and contact info
  - iii. RAL is very interested in offering space, time, city cooperation, etc.
    - A. Jim/Tiffany are setting up a day/time to visit RAL to open this discussion
  - iv. Air Academy Young Eagles for Flabob Flabob requested for us to fly 80 kids via Young Eagles in the summer.
    - A. Initial response: cannot accommodate that number. But we can offer up 10 slots as a special YE event. We will ask for instructors or volunteers to help them we would be more than happy to try to help with a small batch of 15 or so
    - B. Due to time, will revisit at the next meeting as to not rush a response
  - v. Try to get a fuel sponsor
    - A. Might be a great way to bring in pilots
    - B. Tiffany will ask RMS if we get a donation from a corporate sponsor, can we bring in the money and send it back out on fuel.
