#### Meeting Recap

Chapter elections were held during last month's meeting. This is a great group committed to doing well for the chapter and we thank you for your new or continued roles!

On behalf of the chapter, a special thank you to Joel Howard and Grant Garlington for your leadership and fellowship over the past years. We realize other life priorities can pull you away at times and we hope to see your love of aviation and friendship continue with involvement in the chapter.

Also during last month's meeting, we discussed how an ATC clearance (or communication) is not an "authorization" to fly in ADS-B Out rule airspace without being ADS-B Out equipped. Both pilots and controllers are confused on this matter. Controllers are not tasked with the enforcement of this regulation, and a lot of pilots haven't heard of the FAA policy statement (Document Number 2019-06184) governing this matter.

So, the question is, "Is the FAA monitoring for non-ADS-B Out equipped aircraft traversing rule airspace and enforcing the rule?" Answer: I'm not sure yet...

In speaking with FAA's AFS-370 office, I learned that they are recording and reviewing all U.S. ADS-B Out data for performance anomalies. Essentially, they're reviewing the data against the requirements listed in 14CFR91.227, and, when they find issues with any particular aircraft, they send a letter to the owner to address the issue. This office does not look for non-equipped aircraft compliance, and referred me to the office that does. However, they explained that their system is capable of identifying non-equipped aircraft in rule airspace. Since I have not heard back from the FAA on the above question, I'll have to defer to next month's newsletter.

#### Preventive Maintenance

An owner of a certified aircraft having at least a private pilot certificate need not have an A&P license to legally tackle an FAA-approved list of "Preventive Maintenance" tasks published in 14CFR43, Appendix A.

What is preventive maintenance? 14CFR1, section 1.1 defines it as "simple or minor preservation operations and the replacement of small standard parts not involving complex assembly operations."

A few examples of these specific tasks in Appendix A include...

- Removal, installation and repair of landing gear tires
- Servicing landing gear shock struts by adding oil, air or both
- Troubleshooting and repairing broken circuits in landing light wiring circuits
- Replacing bulbs, reflectors and lenses of position and landing lights

This list in Appendix A includes 31 items, but what about other simple tasks that aren't included in the list? Why can I replace position and landing lights, but not an overhead bulb in

the cockpit? I can change the oil and oil filter, but I can't change the induction air filter? If Part 43's Appendix A doesn't make it clear enough, FAA Advisory Circular 43-12A Change 1, paragraph 3.b.(1) regarding the list in Appendix A states "...If a task or maintenance function does not appear in the list, it is not preventive maintenance." Ouch! I can't change that simple overhead light bulb!

But, wait! Have you heard of the "Coleal Legal Interpretation?"

In 2009, Mr. David Coleal, VP and GM of Bombardier Learjet, requested a legal interpretation from the FAA regarding "Whether a Pilot of a Transport Category Aircraft May Check Tire Pressure During a Normal Preflight Inspection."

About a month and a half later, the FAA responded with an official legal interpretation. The short answer was "yes", but they provide a much more general response that is very beneficial to aircraft owners interested in preventive maintenance.

Excerpts from the letter include:

- (1) "Even though the introductory text of subparagraph (c) of Appendix A states that "preventive maintenance is limited to the following work...", in view of the broader definition of preventive maintenance in section 1.1, we believe that such limitation is not controlling."
- (2) "Similarly, for the same reason, we also believe that the following sentence in AC 43-12A is overly restrictive. That sentence, found in paragraph 3.b.(1), states: "If a task or maintenance function does not appear in the list, it is not preventive maintenance. As with the other paragraphs of Appendix A (i.e., on major repairs and major alterations), the lists are better viewed as examples of the tasks in each category-they cannot be considered all-inclusive."
- (3) "It is our understanding that Flight Standards' Aircraft Maintenance Division is planning to clarify this issue in a future revision to the AC." (They have yet to do so)

So, in summary, 14CFR43, Appendix A, is not a restrictive or all-inclusive list, but more a set of examples of tasks that fall into the preventive maintenance definition. I can change that overhead light bulb and induction air filter myself!!!

Just as pilots have personal limits to make a go, no-go decision for flight, you should be careful of taking on tasks you're not trained to do. You should also always utilize the proper maintenance data (aircraft, engine or component manual, supplier instructions, etc.), have the appropriate tools and follow safety guidelines. It's a good idea to ask your IA or mechanic to show you how to do some of these tasks and provide you with the approved manuals if you can't obtain them. The regulations and advisory circular leave a lot of this to your best judgement too, so be careful with your interpretation of what is preventative maintenance or not.
