EAA Young Eagles and Eagle Flights Programs

Launched in 1992, the Young Eagles program introduces and inspires youth, ages 8 to 17, into the world of aviation. As of October 7, 2019, there have been 2,178,152 Young Eagles flown.

How does the Young Eagles program work?

The first step is inviting kids to either attend an EAA National or Chapter rally for their first flight, or EAA-qualified Young Eagles pilots can invite parents and youth in a less formal setting to provide their first flight. In either case, only EAA-qualified pilots are allowed to provide these flights. Also, parents and pilots must sign a registration form prior to the flight.

The pilot will discuss the preflight process and various aircraft systems with the kids, and may even allow kids to take the controls during portions of the flight. Flights are suggested to last 15 to 20 minutes at the discretion of the pilot.

After their first flight, the pilot provides the youth with a personalized Young Eagles Certificate suitable for framing, an informational brochure and their first logbook.

Second, the logbook contains a code that gives the kids free access to an EAA Student Membership which gives them access to EAA Sport Magazine online, enewsletters, free admission to over 300 science and technology museums, and more.

After signing up for the EAA Student Membership, kids will receive a username and password to access Sporty's Learn to Fly Course online (\$199 value). This interactive course is a Private Pilot ground school with in-flight video, 3D animations, and more.

EAA Young Eagles and Eagle Flights Programs

Once the student completes the first 3 volumes of the Learn to Fly Course, they qualify for a free first flight lesson with a flight instructor (must be at least 13 years old). Essentially, the EAA will pay the flight instructor or FBO directly for the first lesson (up to \$130).

Lastly, EAA Student members are eligible for scholarships through EAA. Whether they want to learn to fly, stay at EAA's Air Academy Summer Camp, or pursue a career in the field of aviation, EAA donors provide the funds to support this program.

What about the Eagles Flights program for adults?

If you know someone who is 18 or older that is interested in aviation that would like a free introductory flight, the EAA supports the Eagle Flights program. It provides a free introductory flight experience and informal mentoring program designed to welcome and encourage adults who want to discover flying, but don't know how or where to take that first step. It begins with a hands-on introduction where you'll fly with a local EAA-member pilot who will let you follow along at the controls of the airplane to get a feel for what being a pilot is all about.

After the flight, the mentor pilot can help the adult learn more about how to get involved in your local aviation community, including the next steps you can take on the path to becoming a pilot.

The Eagle Flights adult will receive a free 6-month EAA membership after the completed Eagle Flights registration form is received by the Eagle Flights EAA office.

Insurance coverage for EAA-qualified pilots? Yes, Current EAA members participating in these Young Eagle and Eagle Flights programs are eligible for up to \$1 million passenger liability insurance coverage, if they carry a minimum of \$100,000 per seat liability insurance. This coverage is in place automatically; no additional forms are required, although insurance registration must be done for Young Eagles rally events through the EAA.

As a pilot, these are rewarding programs to inspire the next generations of youth and adults into aviation. Putting my money where my mouth is, I've completed my Young Eagles pilot training and basic background checks, and within the last month completed my first two Young Eagles flights. Seeing the excitement and enthusiasm on the kids' faces, I felt that I was the one being inspired!

The EAA Young Eagles and Eagle Flights programs are explained in more detail at EAA.org. Pilots interested in either program can go to the website to complete the requirements, and obtain handout and registration materials. You can also reach out to your Chapter Young Eagle Coordinator, Tom Egbert, for more information.

Speaking of Tom, Tom has flown 673 total Young Eagles, with 26 recorded so far this year... ...and counting. He is 3rd in Oklahoma in total flown and 1st in the state in the number flown

this year. Tom donates his time and expenses all in the name of encouraging the next generation of aviators. Pictured is Tom with a former Young Eagle he flew, along with her two sisters, when she was 14 in 2015. She invited Tom to attend her \$15,000 GrandAces.org scholarship ceremony. She has passed her private pilot ground course, is working on her A&P and wants to be a corporate or helicopter pilot. Congratulations and thank you, Tom, for inspiring us and our future aviation enthusiasts and professionals!

World Record Attempt - 110 Airports (Follow-up)

As a follow-up to last month's article regarding Dan Moore's attempt at setting a new Guinness world record of "Most Airfields Visited in 24 Hours by a Fixed Wing Aircraft." Dan was able to make 92 airports in about 19 hours before he threw in the towel. The previous record was 87 airports in the UK, so once Guinness reviews all of his submitted proof, he should have the new record.

In a live Q&A video session, Dan admitted that his plan for 110 airports was a little ambitious and his full stop-landings gaining distinguishing photos at each airport took longer than expected.

ADS-B Out Update

In 2.5 months the ADS-B Out mandate will take effect on January 1st. As explained in previous articles and meeting programs, if you're able to steer clear of the Class B Mode C ring (in and above), Class C airspace (in and above) and stay below 10,000 ft, you're not required to comply. Additional and specific details are in 14 CFR 91.225 and 91.227.

The FAA's rebate program closed this past Friday as they completed fulfilling 20,000 \$500 rebate reservations. I know a good handful of folks, self included, that were able to reserve their rebate and complete the process...check is in the mail.

I took advantage of the low cost uAvionix tailBeacon

(978MHz only) solution on my S35 Bonanza (pictured). It retails for \$1995 and I paid \$100 for the installation and 337 paperwork accomplished by my IA. As with the wingtip version, the skyBeacon, it uses your existing Nav light power and ground making the typical install very simple. On the initial power up you have to program the unit by connecting with it over Wi-Fi and using the uAvionix app on your android or apple phone or tablet. Connecting to these devices to reprogram them are password protected which discourages theft.


Once installed I completed a 30-minute (rebate-required) validation flight in rule airspace over KTUL. Approach gave me a squawk code, an altitude of 5,500 ft and heading at my discretion. Pictured is my Foreflight track log. Weather was moving in from the west which explains my trend to the east throughout the flight.


After the flight, I requested the validation flight reports online and filed for the rebate. Once you are ADS-B Out compliant, you can request a Public ADS-B Performance Report after any of your flights at https://adsbperformance.faa.gov/paprrequest.aspx. These reports are

automated and you can expect to receive them via email within 30 minutes of the request.

As a pilot, one of the primary benefits of being ADS-B Out compliant is receiving a better view of rebroadcast traffic if you have ADS-B In capability and an EFB device. Its similar to "see and be seen" that exterior lights and strobes provide. Although it doesn't replace "keeping your eyes outside", it does greatly enhance your view of traffic. Maurice Ingle
