Member of the Month Feature – Robert Bowden

I started my journey in aviation when I joined the Civil Air Patrol as a 14-year-old cadet in Livonia, Michigan. I experienced the joy of flying in a small airplane as part of a CAP orientation flight (very similar to EAA's young eagles flights) in 2003. A few months later I had the opportunity to attend the Johnson Flight Academy (JFA) at KMTO where I had my first flight instruction in a Cessna 172. One year later on June 18th 2004, I completed my first solo at JFA at the age of 16. I returned to JFA in 2005, for the 3rd time to continue my flight training and decided I wanted to pursue aviation in college.


I enrolled at Western Michigan University in the fall of 2006 as a triple major; Aviation Flight Science, Theatre Design and Technical Production, and Music Education. I quickly dropped Music Education as it conflicted with my flight lessons. I was active on campus as a member of the Bronco Marching Band, Alpha Eta Rho International Aviation Fraternity, and The SkyBroncos Precision Flight Team. I completed my Private — Commercial single engine in the SR-20 Cirrus and Multi Engine Commercial in the PA-44 Piper Seminole between 2006 — 2008. Due to a downturn in the aviation industry WMU didn't have any open seats in the CFI course so I went to 35D Allegan to the flight school run by Jason Blair and completed my CFI in August of 2009. In the spring of 2009, I had an opportunity to enter a bridge program with a regional airline, so I dropped my second degree and graduated early, in 3 years, with a Bachelor of Science in Aviation Flight Science. Unfortunately, due to downturn in the industry, the bridge program collapsed so I started flying for Wings of Mercy as a volunteer pilot and started a master's program in Information Assurance at Walsh College in Troy Michigan.

Throughout college I continued to service in the Civil Air Patrol's cadet program with a highlight being a two-week international exchange to Belgium with cadet pilots from 4 other countries. Once I turned 21, transitioned to the adult officer program in CAP where I continued to build time and teach at the Johnson Flight Academy. I serving as a ground instructor in 2008, 2011, flight instructor in 2012, 2013 (2 weeks) and Academy Director in 2014 (2 weeks), 2015 (3 weeks), 2016 (2 weeks), 2017 (2 weeks), 2018 (2 weeks), 2019 (2 weeks), 2021, and 2022 (2 weeks)

My wife Jessica and I met though CAP since only another CAP member would put up with my hundreds of hours spent on CAP every year. We have travelled the country together and started the Civil Air Patrol unit in Harbor Springs, Michigan in the summer of 2020.

Together we own DeAngelo Bowden Aviation which operates a Piper PA-28-180 that was a wedding gift from her grandparents. As the aircraft had all original equipment we spent over a year making upgrades including an Aspen panel, Avidyne 440, Lynx ADSB, JPI 930, and Trutrak Autopilot. Jessica is a student pilot and after graduating with a double masters from the University of Michigan in Engineering Management and Industrial & Systems Engineering next month, will finish up her pilots certificate this summer. I am actively instructing with the goal of becoming a DPE by 2025.

For my day job I am the manager of support enablement and customer success for Barracuda Networks, a large cyber security company based in California. Jessica works for Williams International as a program senior engineer. We enjoy splitting time between Livonia and Harbor Springs and look forward to becoming more active in the Harbor Springs community.
