**January 12th** Tonight Mike Engseth, Tom Tolten, and John McPeak joined in to complete fitting the fiberglass fairings for the vertical stabilizer and rudder. They fit well.



**January 19th** The regular crew, Galen, John, and Tom finished up the vertical stab fairing and started work on the horizontal stab servo actuator. Yes, we are working a little slowly to stretch out the last of the tasks on this first kit segment.

# 2022 CHAPTER 1093 AVIATION SCHOLARSHIPS ANNOUNCED

Chapter 1093 offers two types of scholarships:

- 1) toward completion of a pilot certificate and
- 2) toward completion of a mechanics certificate.

Individuals seeking a scholarship and those seeking to recommend an individual for a scholarship will find the appropriate forms (Application and Recommendation) under Scholarships on the Chapter 1093 web site, <https://chapters.eaa.org/ea1093> Submission information is at the bottom of each form.

Scholarship applications and recommendations will be accepted through the end of March of 2022. Awards will be announced during the Pancake Breakfast currently scheduled for May 7, 2022.

Nominee requirements:

Must be recommended by at least one current EAA Chapter 1093 member.

Must live in Midland or the surrounding area.

Must be minimum age 15.

Must be pursuing a private pilot, recreational, sport pilot license, advanced flight training, or attaining an aviation maintenance certification.

Additional factors to be considered:

Nominee's interest and active participation in Chapter 1093 activities,

Nominee's attendance or participation in Chapter 1093 Aviation Camp

Nominee's sincere and persistent determination to pursue a career or avocation in aviation,

Nominee's current use of own funds for training, and

Recommendations submitted in support of the Nominee.

The most important consideration for any scholarship is the support shown by Chapter members. Do your part to help potential mechanics and pilots to pursue training and achieve their goals - recommend and support. ## EAA 1093 Board Meeting Minutes

January 20, 2022

President Sarah Pagano called the meeting to order at 1707 EST. The Board meeting was held in-person and via Zoom.

Directors in attendance: Dave Fick, Kyle George, Brandon Haskett, John McPeak, Chris Pagano, Sarah Pagano, Arian Perez, Brian Perry

Directors unable to attend: Jeff Gallant, Sarah Haskett, Brandon Marks, Paul Ries, John Sorg

Guests: Jim Murphy, Tom Ryden, Ron Schultz

Minutes from the 11/18/2021 Board meeting were approved (Fick/Perry).

Treasurer's report: Treasurer Fick reported that all accounts have been transferred from Comerica to Members First Credit Union. Debit cards are assigned to President Pagano; no credit cards issued.

Fick presented a proposed budget for 2022, changes were made to reduce the amounts budgeted for name badges and postage. Motion to accept the amended budget by George/Ryden; motion passed.

Membership Committee: Current 2022 membership stands at 47 members.

Members are reminded that 2022 dues are delinquent after 1/1/2022, and can be paid by cash, check, or PayPal.

Hangar Committee: S. Pagano reported that EAA Annex door still leaks.

Most leases have been updated.

Door of hangar 2A needs repair before it can be rented

Young Eagles: 14 Young Eagles were flown on January 8 via several flights by one pilot/one plane.

Scholarship Committee: Per Chair Murphy, both 2021 Ray Scholarship recipients have soloed. The Chapter has applied for a \$10,000 Ray Scholarship for 2022.

The Chapter is now in a new scholarship season, applications are due by March 31 for review and approval in April (forms are online). Recipients will receive scholarships during the May pancake breakfast.

### **UNFINISHED BUSINESS:**

Cessna 150A disposition: McPeak reported that a Bill of Sale to Paul Ries has been created and the Chapter has received a check in the amount of \$2,227 for the purchase. The aircraft parts/pieces are currently stored in hangar 7A2 and are to be removed soon.



RV-12 build project: S. Pagano reported that only one or two more Wednesday sessions are required to finish the current kits. The wings kit has been ordered with a long lead time; no 'crate date' has yet been received, expected delivery is several months out.

Great Lakes Bay Invitational fundraiser: Ryden reported that the Chapter received \$4,500 for participating in the event. Motion to use \$2,250 for aviation scholarships and \$2,250 for the RV-build (Perry/C. Pagano); motion passed. A report was submitted to the MACF on January 17<sup>th</sup> detailing how the monies will be spent.

EAA's Eagle Flights: S. Pagano reported that Eagle Flights (for Veterans) re-scheduled for 11/20/2021 were lightly attended due to date change and marginal weather. Another Eagle flight date will be set for late summer.

EAA Building maintenance: Facility Manager B. Haskett report that one of the refrigerators has failed, suggests replacing the unit with a chest freezer, he will report at next Board meeting.

Aviation Camp/YE Workshop: S. Pagano reported that plans for a February YE Workshop have been postponed.

Aviation Camp 2022 is being planned for June 13-17.

Rusty Pilot Seminar: AOPA will present a seminar on 5/21/22 in the Chapter's classroom, Chapter has been asked to have local CFIs available.

'Flight Night': MPS will sponsor a Flight Night on 4/29/22 for Plymouth Elementary students. Motion to donate \$100 to MPS Science Officer for supplies for educational stations (McPeak/Fick); motion passed. Chapter 1093 will have a couple of stations to 'man' for the event, volunteers are needed (see Sarah Pagano to volunteer).

Holiday/volunteer recognition party: S. Pagano reported that event was successful, though lightly attended. Next season's holiday party will follow same format.

Chapter renewal with EAA: S. Pagano reported that renewal is complete for 2022.

### **NEW BUSINESS:**

Congratulations to Sarah Pagano who has been appointed to the EAA Chapter Advisory Council, an oversight committee of EAA, for a full term.

Former Chapter member Lewis Webster has offered to donate hangar 3J and most of the contents (two partially built aircraft, two round engines, shop equipment, documentation) to Chapter 1093. Motion to accept the donation of hangar 3J and contents by C. Pagano/Perry; motion passed. A letter of acceptance will be sent, and details of the transfer of ownership will be worked out with Mr. Webster soon.

Investment Committee: Ron Schultz reported that the fund has grown from its inception in 2013 with \$15,000 to the current market value of \$109,000. The fund is balanced at 28% bonds and 72% equities. Motion by C. Pagano/Fick to direct the Investment Committee to withdraw \$15,000 from the account to be used for the purchase of kits for the RV-12 build; motion passed.

Motion to order the next RV-12 kit (fuselage) when funds are available (C. Pagano/Fick); motion

Chris Pagano requested that the new Directors submit a profile picture for the Chapter website - Kyle George, Arian Perez, Brian Perry.

President Pagano adjourned the meeting at 1837 EST.
