Secretary's Report- September 11th, 2022

EAA Chapter 1127 met on Sunday, October 9th, 2022. The meeting began at 2:30 with a family cook out. It was a pot-luck meal with meat provided by the chapter and grilled by Marty. Anybody that left hungry could only blame themselves!

Vice-President Max Liby called the meeting to order at approximately 3:30 pm. There were 25 members and guests present with Scott Jones joining us again this month. Welcome Scott!

Minutes from the September meeting had been circulated with the newsletter. Milton made a motion that the minutes be approved as presented in the newsletter. Darwin seconded. Motion carried.

Treasurer's Report:

Jim reported that our checking account balance is \$3,536.71. In addition to the checking account, we also have money in savings available for when we find an appropriate use. (Approximately \$4,380.)

Young Eagles:

Keith reminded us that Young Eagle Flights are scheduled for Ellsworth on November 5 from 9:00 a.m. until 1:00 p.m. He circulated sign-up sheets for pilots and other volunteers. If weather does not allow flights on the 5th, November 12th at the same time will be the alternate date.

Max informed us that Dale had some additional materials for the Young Eagle participants to do while they waited for the chance to fly. Involves some sectional charts and some basic questions to help learn how to use the sectional charts.
