At 6:45 p.m. President Charlie Bates and Kirk Sampson called the gathering to order.


May 18 will be the first Poker Run sponsored by Chapter 129. There are five stops where pilots will pick up a playing card, Champaign, Decatur, Springfield, Mt. Hawley and Bloomington. The chapter will cook burgers and brats at the EAA hanger F-15 and prizes will be awarded to the best hand. Thanks to Matt Kerner for developing the poker run and contacting the supporting FBO at the participating airports.

At 7:00 p.m. Charlie and Kirk introduced a movie telling the story of the Women Airforce Service Pilots who trained and flew virtually every airplane built during the second world war. The program was the idea of Nancy Harkness Love and Jackie Cochran. More than 1,100 WASPs served between 1942 and 1944, ferrying aircraft between

U.S. bases, testing fighter planes and towing targets for men to practice shooting at with live ammunition.

They flew every type of aircraft flown by the Army Air Corps, including the B-24 bomber – also known as the "widow maker" and the B-29 Superfortress. Thirty eight of them died while serving their country. The WASPs were disbanded

in 1944 as the war in Europe wound down and more male pilots were available. The women who served were not recognized as members of the US military and were not granted veteran's benefits. In March of 2010, those



who served as WASPs were finally granted the Congressional Gold Medal, the highest honor Congress grants to civilians.

One local WASP, Ethel Jones Sheffler from Heyworth, returned home to Bloomington and became a flight instructor. Several members of Chapter 129 had Ethel as their flight instructor at Clark Aviation.

The meeting concluded at 8:30 p.m.

AEROSPACE SUMMER CAMP


n June 24th through 25th the Children's Discovery Museum (CDM) in Normal is sponsoring an Aerospace Engineering Camp for 20 students in grades 3 - 6. EAA Chapter 129 is partnering with the CDM, Central Illinois Regional Airport (CIRA) and the Prairie Aviation Museum (PAM) on this event. The students will spend Tuesday, June, 25th and Wednesday June 26th, at CIRA. The students will arrive at the EAA Hanger on Tuesday and will spend the morning learning about the airport, the history of flight and participating in aviation related activities. After lunch, CIRA has arranged for a tour of the airport including the control tower, fire station, terminal and the OSF Life Flight hanger. While on the tour, the students will be asked to do a scavenger hunt to identify certain items located on the airfield.

Wednesday morning events will also be hosted by Chapter 129 at the hanger with educational activities related to aeronautics

including a "preflight" of an airplane. The morning will also include activities related to weather and the engineering design process. The students will spend the afternoon at the Prairie Aviation Museum.

Special thanks to the CDM for this opportunity and as always, thanks to our partners at the airport including CIRA and PAM. Thanks also to members who have agreed to bring in their airplanes to help provide an enhanced experience for the students.

Honoring Our Veterans

May 25 and May 27, 2024 members of EAA Chapter 129 provided Honor Flight flybys for Memorial Day ceremonies sponsored by the Normal American Legion Post 635 and Bloomington American Legion Post 56.


On Saturday the 25th, member pilot Paul Kruger with observer Mike Gilmore, pilot Doug Reeves with observer Charlie Bates flew over Eastlawn Memorial Gardens as a white horse drawn hearse carried a ceremonial casket to the mausoleum. The Legion Honor Guard provided military honors, a 21 gun salute a bagpiper and taps being played.

On Monday, the 27th , member pilot Paul Krueger and observer Jim Visel, pilot Charlie Bates and observer Collin Sampson and pilot Doug Reeves and observer Wayne Sampson flew over Evergreen Memorial Cemetery as the Legion Honor Guard presented a military honor service for family members who had lost a veteran and had not received prior military rites. The service concluded with a 21 gun salute, bagpiper and taps being played.

Prior to each flight, the pilots and observers prepare a detailed flight briefing and safety plan. The Honor Flights are always coordinated with the Central Illinois Regional Airport control tower staff. Using a predetermined flight path, time for passing over the ceremony and plan for return to the airport, each flight is carefully detailed prior to departure.

Upon return to the airport, a safety debriefing is held to review the flight and discuss each part of the flight for safety.

CIRA - from the Operations Desk



From The Desk of the DED (that's deputy executive director....Derek Snyder)

May and June are busy months for the Airport as we tie up loose ends and put the administrative bows on several upcoming construction projects. There is a lot of work that needs to be completed before a project can be issued a notice to proceed. Did you know that projects, regardless of size, usually begin two years or more before shovels are put in the ground? Planning, financing, environmental clearance, scheduling, permitting, coordination with FAA, IDA, state and local, are just some items that begin years before construction can begin. We are fortunate to work with a professional group of peers from various agencies that make it all happen.

GA Phase II

- o Construction crews will be mobilizing equipment and starting the final phase of the new GA Facility in the first week of June.
- o After Oshkosh, around August 5th, we are planning for a hard closure of Runway 11/29 to perform work in the RSA (i.e., connect new taxiways). The plan is for this closure to take approximately 35 days to complete the work inside the RSA, however, weather conditions could cause this to extend longer.
- o This phase is expected to have a significant



amount of construction completed by the end of the calendar year but will have carry over into 2025.

Badging

- o Badge Renewal season is underway for AOA badge holders. This year's badge template is slightly different than in previous years. New AOA Badges will have a solid orange background to help with contrast of wording on the badge, as well as make it easier to identify from a distance. Reminder when coming in for your badge appointment, please have two forms of acceptable identification with you.
- o For new AOA badge applications.....If you were born outside of the United States, please ensure you bring in the associated paperwork/identification for being born abroad. These badges will take at least 30 days to be vetted so bringing all supporting paperwork is encouraged.
- o More badging information can be found at: https://cira.com/employees-tenants/badging-procedures/

FOD

- o Everyone with access to the Airport is a team member of the FOD management program. Please do your part to help pick up FOD and dispose of it properly, for any special FOD situations please contact Airport Operations at 309-834-7396.
- o Airport Maintenance will be present weekly for FOD removal utilizing maintenance equipment fitted with FOD collection boxes, so be aware of those operations, NOTAMs will be issued.
- o Multiple Airport construction projects could bring a higher potential for FOD. The construction sites are inspected by Airport Operations at the end of each day to help curb the FOD from those locations.

Wildlife

o Airport Operations staff does a stellar job implementing the Airport's Wildlife Hazard and Management Plan. However, they cannot be everywhere at all times......if you see wildlife that presents a safety issue to aeronautical activities, please contact Airport Operations at 309-834-7396 immediately. (this constitutes wildlife observed from the ground (while at your hangar or sitting on the ramp doing a run-up) as well as in the air (in the pattern or on Final)).

I am excited to give a Sneak Peak on a "topsecret" project we've been working on. The Airport Authority has been working hard developing a new website specifically for tenants. This will allow tenants the ability to electronically submit hangar maintenance requests, pay their monthly hangar bill, receive important updates via a message board, etc. This is planned to be rolled out this summer, so please keep an eye out for a letter to come in the mail.







WINGS - Pilot Proficiency Program

The objective of the WINGS Program is to address the primary accident causal factors that continue to plague the general aviation community. By focusing on this objective, we hope to reduce the number of accidents we see each year for the same causes. As you will see, it is not a simple "Award" program but is instead a true proficiency program, designed to help improve our skills and knowledge as pilots.

The **WINGS** - Pilot Proficiency Program is based on the premise that pilots who maintain currency and proficiency in the basics of flight will enjoy a safer and more stress-free flying experience.

You select (in your Airman Profile) the category and class of aircraft in which you wish to receive training and in which you wish to demonstrate your flight proficiency. Requirements for each aircraft category and class include specific subjects and flight maneuvers. To ensure you receive a well-rounded learning experience, only certain flight activities fulfill specific credit requirements. More information about how these subject areas are selected is available on your MY WINGS page.

The program encourages an on-going training program that provides you an opportunity to fly on a regular basis with an authorized flight instructor.

The program is most effective if the training is accomplished regularly throughout the year, thus affording you the opportunity to fly in different seasons and in different flight conditions.

Reviewing and refreshing your knowledge is just as important as actual flying. To meet this goal, we provide you many opportunities to complete online courses, attend seminars and other events, and participate in webinars. Many 3rd party activities, such as those offered by AOPA, ASA, Sporty's, Gleim Publications, and others, qualify for WINGS credit and will indicate such credit on their web site.

In almost all cases, arrangements have been made with the FAASTeam to automatically provide WINGS credit after the activity. However, please allow at least 24 hours before inquiring about WINGS credits. Remember, if you have questions about a course or activity, check with the provider. If you have a question about the WINGS Program, contact faasafety@faa.gov

Note that completion of any Phase of WINGS satisfies the requirement for a flight review. So not only will you complete a review of the most common weak areas that have led others to the accident site, but you end up with a flight review, as well!

- 1) **c** Since the majority of ground control frequencies are in the 121.6-121.9 MHz bandwidth, many tower controllers use the abbreviation "ground point niner" when they want you to contact ground control on 121.9.
- 2) **b** Since you're below 10,000' MSL, you're limited to 250 knots. However, Class B airspace doesn't specifically limit your airspeed.
- 3) **No** Taxi instructions start with the assigned runway, then specify the taxi route and any initial runway crossing and/or hold short instructions. You've been cleared to cross the runway..

- 4) **f** A hollow circle indicates an airport with other than hard-surfaced runways (like grass or dirt), or an airport where all hard-surfaced runways are less than 1500' long..
