September 14 Chapter Meeting Notes (21 Attendees)

Mike Robertson, President, opened the meeting by notifying the group that he would be stepping down as chapter President. As per the organization's bylaws, the current Vice President, Chris Wallace, will take his place on an interim basis until the end of his term on December 31, 2022.

Chris introduced himself and provided a quick overview of his background as an Air Force pilot, then becoming a commercial pilot with United Airlines for 30 years, as well as ownership of private planes many years ago. He is currently starting to build a Sonex Waiex from a kit at Bend Builders Assist.

Tom Wright shared a video of a mid-air collision over Watsonville Airport in California that occurred in August resulting in the death of all 3 passengers in the two airplanes. The group discussed the situation and what safety measures might have prevented the collision. We hope the safety discussion will become a feature in future meetings. It seemed to be well received and generated a very lively interactive discussion. Young Eagles Chapter Best Practices and Risk Management Submitted by Young Eagles Committee Member Tom Wright

Beginning in December 2022, the EAA will require Young Eagles Coordinators to register and complete a mandatory risk management online course. Our Chapter needs to fulfill this obligation for any Young Eagles event in 2023. Below is an excerpt from EAA's communication explaining why they are requiring this new risk management training:

Over the past year, EAA has seen a rise in inappropriate Young Eagles practices. These practices have ranged from incorrect waiver usage or outright failure to use it all to co-mingling the Young Eagles flights with third party organizations and improper reporting. These practices put the program, and the insurance coverage provided to the program, at risk.

To better inform Young Eagles volunteers of the current program guidelines and requirements, EAA will be launching Young Eagles risk management training in December 2022. This training will consist of a 30-minute pre-recorded webinar and short quiz. A quiz score of 70% or better will be required to pass the course. Similar to youth protection training, this course will need to be completed every three years for renewal. Only Young Eagles coordinators will be required to complete this training before your chapter's first rally of 2023, or by April 30, 2023, whichever occurs first. Although not required, other Young Eagles volunteers and chapter officers are highly encouraged to take this training.

I will be taking this training and encourage others too. Much like building aircraft, the Young Eagles program is an essential part of EAA. The Young Eagles program has a well deserved reputation because of the dedication, enthusiasm, and focus on safety from the front-line volunteers. Let's continue to do our part.
