Airworthiness Certification Step One Daniel Folkers DAR-T

In today's Techno" age we can do most anything from the convenience of our living rooms and never leave the couch. Pay bills, order a pizza and yes apply for an Aircraft Airworthiness Certification. There is an adopted process now within the FAA and your certification will start there. Let's take a look.

Many of us aviators that have interacted with the FAA in recent years have already been asked to apply for and generate an AWC account online within the FAA Website. AWC is the acronym for Airworthiness Certification (Portal). This newly developed portal is quickly becoming the FAA's starting place for all sorts of general aviation regulatory requests which could include issuance of Ferry Permits, Import / Export of foreign aircraft, replacement of lost or damaged Airworthiness Certificates and yes the issuance of your new Amateur Built Airworthiness Certificate.

Your personal AWC (portal) or account can be applied for anytime during the building process and once issued stays with you for as long as you are involved in U.S. aviation activities. If you haven't interacted with the FAA in the recent past then completing the task of developing your personal online AWC portal is step one for Aircraft Certification. The process is fairly self-explanatory and takes about a half an hour. Remember to jot down your user name and passwords as this account will stay with you long into the future.

Your personal AWC (portal) or account can be applied for anytime during the building process and once issued stays with you for as long as you are involved in U.S. aviation activities. If you haven't interacted with the FAA in the recent past then completing the task of developing your personal online AWC portal is step one for Aircraft Certification. The process is fairly self-explanatory and takes about a half an hour. Remember to jot down your user name and passwords as this account will stay with you long into the future.

Many builders early in their project choose to follow FAA document AC-20-27(G) or latest Rev, titled *Certification and Operation of Amateur-Built Aircraft*. This document lists detailed steps in building and certifying Amateur built aircraft and can be useful in greasing the path towards a successful build and certification. If for whatever reason this document was not use during your build it's not too late. Whether from the beginning, in the middle or at the end, the information included in this AC will prove valuable towards your end goal. This document lists the individual applications required and their progression through AWC. I recommend you download a copy soon and familiarize yourself with its guidance. At our next visit we will discuss in detail the documentations listed in this AC there purpose and more. Tailwinds.
