- John Knorr airport commission projects update
 - Hangar project is 99% probable. SW side of airport. 2 buildings. Final configuration is TBD. The hangars cannot be built with state or federal \$s. They will be Nested T hangars.
 - New Taxiway F and G west end of airport off rwy 7.
 - Big concrete apron on NW corner of airport. This is in support of Bemidji aviation expansion plans.
 - Main terminal security upgrade driven by larger air carrier capacity coming. MAY have to change the security at the access gates. May have to expand fire and rescue as well.
 - BJI provides \$48M/year in economic impact to the BJI area.

- Pursuing the final resting place of a B-29 that crashed in Upper red lake in 1945
- Aircraft took off July 14th 1945 out of Pioti Army airfield in Texas, on a training mission.
 This is where the B-29 crews were trained. Flew to Hobbs NM, Duluth MN, marcom lake MN, wolf point MT, Hobbs, Pioti. Got a fuel odor when the FE first transferred fuel.
 They bailed out over Big Fork. Everyone lived. Aircraft never found. Looking for aircraft. Likely in upper red lake.
- Dragged hooks on bottom and identified object
- Side sonar trip is on 1/20 22 to scan for remains. Participants are welcome to come along.

Mark Cook

- o Trick air ski Plane Fly-In on 1/21 at Jackson sea Plane Base (Northeast of McGregor)
- Flying club is up and operational.
- Bemidji Aviation has purchased a Sioux Falls company called Oncor. Needs pilots desperately. They now have 60 planes.
- The FAA has released the medical reforms. If under 40 continue getting 3rd class medical. Every 24 months must take on line course. Every 4 years must get a physical. AC-68-1 provides details. System up and running May 1st. https://www.faa.gov/documentLibrary/media/Advisory Circular/AC 68-1.pdf
- Wings seminar: Best Glide. Forced landings. If not stable (on speed and configured for landing) at 500 AGL we go around. Vx is best angle of climb Vy is best rate of climb. The best glide speed is somewhere between these 2 speeds. Vx and Vy both increase with altitude. Best glide speed is: speed to fly for greatest distance or longest time. It is L/D

Max. Typically it is 4-6 seconds before you recognize the engine failure. Have a plan before takeoff and brief it, even if solo.
