## **Business Meeting**

  - o Larry Diffley and Mark Shough met in California.
  - o Waldo Waddles was previous FBO owner. Larry and Mark Purchased in 1970
  - Started passenger service with Queen airs in the 1980s
  - Began running checks with piper Aztecs
  - o Began UPS route in 1994
  - Today (what we do now)
    - UPS is 80% of the business
    - ESOP as of 2006
    - Larry passed away 2011. This was a major turning point in the company
    - Ramp Services
    - Customer/pilot services
    - Aircraft Rental
    - Maintenance
    - Structures Repair; buy non-flying aircraft and make them flyable
    - Paint
    - Engine overhaul
    - Fiberglass and vacuum form parts
    - Avionics
    - Photo flights
    - Fire detection
    - Instruction
    - Passenger charters
    - 107 employees
  - Where are we going
    - UPS wants us to be one of the 3 feeder cargo operators in 10-15 years
