EAA Chapter Hangar: The chapter has a hangar for the use of members and their projects. The EAA chapter hangar has a reference library. We will be revising the contents based on usefulness. The hangar has most of the tools needed to build your very own aircraft. There is a Chapter Hangar Use form, with suggested donation levels.

Fund Raising Ideas: 47 members x \$35 = \$1645 which is short of the \$4255 expenditures needed to run the chapter. Fund raising ideas were discussed, and included: Cookouts, Pancake Breakfast Fly-Ins, "50/50" Raffles, Chili Cookout Fly-In, Poker Run, Camping event @ Riverview, Paper Lantern sales, T-shirts with Sponsorship sales, Advertising Sponsors in newsletter, Ford Tri-Motor flight sales, Griffins / Whitecaps 50-50 raffle sales. If anyone has fund raising ideas please talk with a chapter officer.

2020 Monthly Programs: February: Herb Harney – Bahamas Trip Preview. March: EAA VFR Club – Radek Wyrzykowski. April: FAA Seminar-"Brushing off the Rust". May: RV-14A Project – Bob Swietek - if anyone has ideas for monthly meetings please talk with V.P. Bruce Whitman.

Special Events with other EAA Chapters: For events with a wide interest (STRATUX DIY ADS-B, Aviation Weather, etc) we will announce this to neighboring EAA chapters. This helps communication between groups and aids in keeping the aviation-minded people close, and not feel isolated. Also, if another chapter has an event, we will not plan an event for Riverview. Multiple events around the area takes away the amount of folks that will attend our events.

Camping Flights/Big Tour Flights: the chapter will keep in contact Herb Harney and other area pilots to get trip locations and dates, then pass on information in the newsletter and on the bulletin board.

Chapter Group Flights: Fly outs for the group were discussed. This would allow aircraft with limited size and speed to participate in



the group flying activities. Destination examples include Mackinaw Island, Beaver Island, Watervliet camping, Charlevoix, etc.

Oshkosh '20: We are looking for an "Oshkosh Camping Champion" – someone that can coordinate the chapter camping at Shollers. If there is no interest, we could lose our "legacy" saved spot that has been the home for #145 for so many years. Chapter campsites will be staked out in the order requests are processed. Chapters that wish to sign up for chapter camping must be registered and paid for by June 30, 2020

Activity Planning: Activities for the upcoming year were discussed, among those were Oshkosh Airventure, Young Eagle flights, Eagle flights, Boy Scouts of America Aviation Merit Badge Day. Besides the October bonfire and Christmas brunch, we talked about a Riverview Airport Open House day, and a Chili Cookoff Fly-In event.

There is interest from a few S.T.E.M. programs in the area. A group from Grand Valley, and a group from Rockford are looking to aviation and how it relates to science and technical fields. We would work with those groups to tell them the many career paths aviation offers, and the science behind the way aircraft are able to fly.

Membership Directory: we discussed making a chapter membership directory. The directory would help bring members together, and locate someone that has a project the same or similar to theirs. Or if someone has special skills that could help others (CFI, A&P License, IA, welder, etc). The directory would help knowledgetransfer and foster conversations, and help members get to know each other better. The directory would have contact information, aircraft owned or built, special technical skills, ratings earned, etc.

Riverview Hangar Directory: Discussion was had on the best way to publish the hangar directory of Riverview Airport. The directory allows people that have an interest in a particular type of airplane (RV, Cub, Rans, 182,etc) to find and gain knowledge on that airplane type (pros/cons, costs, flight behavior, maintenance issues). The directory allows owners of same or similar types to find each other and share ownership knowledge. The directory may be combined with the EAA membership directory.

Other: If anyone has ideas / concerns for the chapter, please talk with any chapter officer. This group can excel when everyone contributes. The group allows members to make connections with other aviation minded people, to learn and share knowledge in this technical field, to inspire and be inspired to move ahead with new skills or venture off to the next destination.

We want to thank those that helped with events and went the extra mile, we could not have done it without you. The Boy Scouts Aviation Badge program was well attended and we had good volunteers to make the day go smoothly. The Wings of Mercy, Grand Haven, and Greenville Young Eagles event are always hectic, but with enough people we manage to succeed and produce a good event.

WEST MICHIGAN EAA CHAPTER CONFERENCE

Officers and other interested members of West Michigan EAA chapters met recently to coordinate the busy summer weekends. We had representatives from Fremont Chapter #578, Kalamazoo Chapter #221, Grand Rapids Chapter #145, Sparta Chapter #704 and Grand Haven Chapter #211.

The main focus of the meeting was to plan out the busy summer weekends. Coordination is needed so competing events do not happen on the same day. Aviation is a small community and we want to avoid diluting the number of attendees that may attend each event. Also, if there happens to be two Young Eagle events on the same day, it would be very difficult to find enough pilots to fly all the kids, and volunteers to help with the supporting roles. Having separate events allows members to volunteer at the neighboring chapter's events. We can all help each other and make each event better.

Other subjects were discussed: 'Flying Start' or Eagle Flights, where someone over the age of 18 can get a flight and learn about aviation & training. We talked about the sharing of resources and information – a certain chapter may have an expertise in a certain area that would benefit neighboring chapters. A certain chapter may have a lot of experience with a particular kitplane and could offer valuable advice to newer kit builders – for example - RV's at Riverview or Carbon Cubs at Sparta. We wanted to open the lines of communication with each chapter, to be stronger together than we are separately.

We talked about outreach programs with schools and other organizations to get the youth interested in aviation. We talked about participation in West Michigan activities to promote EAA and aviation, such as S.M.A.T. Open House, the G.A.A.A. events and the Plainwell S.T.E.M. programs.

FLYING UNDER ADS-B Unequipped aircraft may require extra steps By Mike Collins For aircraft not equipped with ADS-B Out, flying in certain U.S. airspace changed Jan 1st.



In the continental United States, the equipment will be required to operate in the ADS-B rule airspace defined by FAR 91.225, which encompasses:

• Class A, B, and C airspace;

• Class E airspace at or above 10,000 feet msl, excluding airspace at/below 2,500 feet agl;

• Within 30 nautical miles of a Class B primary airport (the Mode C veil);

• Above the ceiling and within the lateral boundaries of Class B or Class C airspace up to 10,000 feet;

• Class E airspace over the Gulf of Mexico, at and above 3,000 feet msl, within 12 nm of the U.S. coast.

Except for the airspace over the Gulf this is the same airspace where a transponder is required today. If you're not equipped with ADS-B Out, you're not necessarily shut out of the airspace—but you'll have some extra work to do.

The FAA developed an automation capability to manage ATC authorization requests, the ADS-B Deviation Authorization Preflight Tool (ADAPT). The rules require that you request an airspace authorization from the FAA website at least one hour but not more than 24 hours in advance of your flight. Don't call the ATC facility to ask, and don't request access from a controller over the radio—the answer will be "no." Only if your ADS-B Out hardware fails in flight will controllers be able to issue an airspace authorization to an airborne aircraft, said Rune Duke, AOPA senior director of airspace, air traffic, and aviation security. An operational transponder is required, he added, and aircraft without engine-driven electrical systems that don't have transponders also are exempt from some of the ADS-B required airspace, but not all.

The FAA said that ADAPT is scheduled to go live on December 31, and in the meantime, pilots can familiarize themselves with it through a video the FAA has posted online. A link to the live ADAPT website should be posted on that page as soon as the service becomes available. In addition, AOPA has produced a comprehensive ADAPT Fact Sheet that includes step-by-step instructions for completing the process.
