Knocking off The Rust, Spring Flying

Tom Kozura will be our featured speaker this May. Our chapter was fortunate to visit Tom and see the progress on his Sopwith Camel, which is an incredibly detailed construction. (Tom has also built five other aircraft.) Tom is an FAA inspector, program manager for their FAST Team (FAA Safety Team) and has a long background in aviation. He was a pilot flying B-52s and E-3s for the USAF, flew for Northwest Airlines and operated a flight school in Sparta.



Tom's topic will address getting back into flying, such as after the winter layoff. "Your first flight of the year should not be going into Oshkosh." Perhaps it shouldn't be any long cross country trip. Yes, we need to be current to carry passengers, but what level of proficiency should we be comfortable with and how to we get to that level? FLYING YOUNG EAGLES AND ADULTS

Were you aware that you could individually fly a youth (8-17 years) or an adult (18 or older) under one of two EAA programs?

Many of our chapter members volunteer to help with Young Eagle (YE) events to introduce young people to the amazing world of aviation. But were you aware that you could fly an individual without waiting for a YE event?

Two programs from EAA nationally are available to you:

Young Eagles is designed to introduce youth, aged 8 up to 17, to aviation with a free rider in a small aircraft (up to 3 kids), with parent permission.

Eagle Flights are for sharing the aviation lifestyle with adults, aged 18 and up, with a one-on-one introductory flight.

And we need pilots. The requirements are fairly straight forward and apply to both Certified and Experimental aircraft: Pilots need to be EAA national members, current with medical, current to carry passengers, current with their flight review, have proper insurance, and comply with the FAA regulations. This is the stuff most of us should be doing with our aircraft. To fly Young Eagles, pilots need to complete Youth Protection Training, free of charge from the EAA National website. EAA then provides a million dollar insurance policy for the flight.

Detailed information is available online: see YoungEagles.org or EagleFlights.org, both of which are accessed through the national EAA website. More details, materials and suggestions are displayed there.

CHAPTER HANGAR DISCUSSION

At the May 13 meeting, we will have a discussion whether to keep renting the Chapter hangar at Riverview or return the hangar back to Riverview Airport (08C).

Through the years the hangar has been a good asset. Many aircraft have been built there, and improvements such as insulation and heat have been made. However, the hangar has become a liability. The lack of projects means there is no revenue to offset the rental costs. Plus there is a cost for insurance that EAA HQ provides to cover liability for a Chapter hangar.

The Chapter will be out of money if we do nothing. The hangar is costing four times the amount of incoming Chapter dues. Regarding fundraising options, we could host pancake breakfasts or do other things to raise money, but the money primarily would be going directly to pay for an empty, unused hangar. Those funds could be going for better uses.

We are at the point where a difficult decision must be made. The Chapter officers would like input from the membership to help make a decision at the Chapter meeting on May 13.
