

# **EAA Young Eagles**

- There have been request(s) for "one-off" Young Eagle flights
  - No Tree top Flyer Rallies
  - Pilots can do flights within parameters
    - ✓ Be a current EAA member
    - ✓ Complete EAA's Youth Protection Training and background check
    - ✓ Order your own Young Eagles supplies (log in to EAA)
    - ✓ Prior to Young Eagles flight, meet all pilot requirements, guidelines
    - Complete Young Eagles registration form before flight, signed by you and a parent or legal guardian





## Young Eagles Pilot Requirements



- ✓ Be current EAA® member hold appropriate airman's certificate (sport pilot or greater).
- ✓ Possess a current medical certificate (if applicable).
- ✓ Be current to carry passengers in the aircraft you plan to use.
- ✓ Have a current flight review.
- ✓ Complete the Young Eagles registration form before the flight, including parent or legal guardian signature, and pilot signature.
- ✓ Conduct flights in an aircraft that is in airworthy condition.
- ✓ Have aircraft passenger liability insurance for the aircraft used (owned, rented, or borrowed) with \$100,000 per seat coverage.
- ✓ Adhere to all applicable Federal Air Regulations (FARs).
- ✓ Complete both the online training and basic background check as a part of EAA's Youth Protection Policy. For more information visit EAA.org / YouthProtection.

# VFR cross country flight - VFR-equipped 1977 C172, - flying by pilotage at 3000 AGL

 Returning later than planned... friend ask to make call to spouse – Note, no onboard electronic navigation...is it legal to let your friend make the call?

#### **References:**

AC 91.21-1D and (47 CFR) part 22, § 22.925

### **Answer:**



#### No, it is not permissible

- "The FCC prohibits cellular telephone operation while airborne,
- Valid for all aircraft without technical provisions that enable control of onboard mobile devices to eliminate interference between groundbased cellular stations and airborne cellular devices.

#### **Exceptions**

• If technical provisions are installed, compliant with, or exempt from 47 CFR § 22.925, then usage of cellular-enabled PEDs is acceptable."
