## Young Eagles Update by Ellie Repp - 309-335-2887

At the last Chapter Gathering we polled the group and decided that May 22, 2021 will be our first official Young Eagles Rally! In order to get the bugs worked out and get a system in place, we have opted to have a closed registration for this event. I have been in contact with the leader (Lora Wright) of Girl Scout Troop 3019 which has around 12 girls in 6th-12th grade. They have actually made a visit to the Stearman Fly-In in the past; it was a big hit! Lora is very excited about this opportunity and thinks the girls will be, too!

We currently have 2 confirmed planes and pilots for this event (and a couple "it depends on farming"), and two confirmed ground crew. It'd be great if we had a few more confirmed, so check your calendars and let me know if you would be able to help! Lunch will be provided to volunteers after the event!!

On a similar note, we'd really like to name an official Young Eagles Coordinator! If you're questioning whether this would be a good role for you, please reach out and we can discuss more details on what it would entail. As our Chapter grows,

our Young Eagle Program will, too, so this single Coordinator position will hopefully expand into a full-blown committee. There are a lot of cool things we can do that EAA already provides guidance and materials for, so you will NOT be alone in this role at any point!

It was also mentioned at the Gathering that in order to hold youth events, we may have to get background checks done with the Galesburg Police Department. We followed up with our most recently retired Police Chief and determined that the City offers a service where you can get a background check done if an event requires it and that event does not offer the resources to get the background check. EAA requires and offers a background check for youth events, so we are all set and do not need an additional background check by the City of Galesburg.

Once again, thanks to those who have already volunteered for this Rally and thanks to those who will!;)

**B 17 VISIT.** Aaron Repp made a presentation at the Chapter Gathering about a visit by Aluminum Overcast, the EAA B-17. Aaron was chosen by the Board of Directors as the Tour Stop Coordinator because of his extensive prior experience with airport management and operations, not to mention general aviation activities. Aaron made a substantial and detailed presentation about the visit which no doubt will evolve as efforts are made to coordinate the visit with the Stearman Association, the EAA, the City of Galesburg and related entities.

As part of this effort, Aaron and other chapter directors Matt Jern and Bill Hurley met with the Stearman and Stearman Fly-In representatives on Monday February 15, 2021 to discuss the planning and organization of what will effectively be two special events in their own right. Issues discussed were widely diverse and included parking of participant aircraft, ramp use, activities and evening entertainment, general public access and general requirements for a successful event. Immediately following the meeting with the Stearman representatives, Aaron Repp and Bill Hurley held a conference call with Ron Eisele, the EAA Event Coordinator. Questions and requests directed to facilitating the B-17 visit contemporaneously with the Stearman Fly-In and the Chapter's involvement had previously been presented to Mr. Eisele by the Board of Directors. He promised follow-up by EAA National.

Additional meetings of the Board of Directors on February 23, conferences with city engineers/planners, and a meeting of the Chapter Board with Stearman, Jet Air and Galesburg Parks and Recreation and Airport Management People on February 25 have all taken place. It has been a very busy month.

That said, Mr. Eisele and EAA National has advised the B-17 will not arrive until September 8 due to other prior engagements. Also, the EAA is not presently, and will not through June, be conducting interior ground tours of the aircraft due to Covid 19 protocols. Whether this will change or not by next September

remains to be seen. No ground tours would limit potential chapter revenues from the event. So far the aerial tours appear unaffected. Also, current plans now have the B-17 ramp area to be at the southern end of the ramp to provide better visibility and separation of the different activities, facilitate static displays of other aircraft and provide better ingress and egress to the ramp for transient or participating aircraft.

In addition, Aaron has procured Chris Henry as the keynote speaker for the Friday night activities. He is the EAA Aviation Museum Program Coordinator with EAA National and has written a book about the B-17. It should provide for a very interesting presentation. Stay tuned for further updates!

More volunteers are needed to help with the event. Ellie Repp is the Volunteer and Logistics Coordinator. If you have not previously logged your name on the volunteer signup sheet and wish to volunteer, please sign the volunteer sheet at the next gathering or contact Ellie Repp.

The Board of Directors does wish to recognize and thank Nate Compton for volunteering to be the Chapter Marketing Chairman. Nate has the technical expertise to assist the Chapter with its future advertising and marketing efforts. The Board confirmed Nate as the marketing chairman at its meeting on February 23.

The Board of Directors also wishes to recognize and thank Ellen Larson who has volunteered to be Co-Chair of the B-17 Marketing Committee and, along with Nate Compton, will be working to coordinate advertising with local media outlets to get out the word about the B-17 visit. The Board confirmed Ellen and Nate as Co-Chairs of the B-17 Marketing Committee at its meeting on February 23.
