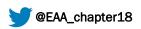

It All Started Here...

And He Was Here to See it !!!



Only 175 Days to Oshkosh!





When Ron Romans was fifteen years old he had a passion for model airplanes. He jokes that he was saved from smoking by propellers. Model airplane propellers were 25 cents at the time, about the same price as a pack of cigarettes. For Ron, props broke fast, and often, so there was no time or money to stop and have a smoke. The lungs that he saved from smoking powered him around Milwaukee on his bicycle. One day in 1954, he was riding past a farm near 91st, south of Hampton, and he noticed that the silo he that had seen hundreds of times was now painted with a bright yellow and black checkerboard. Small planes were buzzing around the silo and flying back towards Curtis Wright airfield. Immediately, Ron hammered his bike over to Curtis Wright and found himself outside the Second Annual Milwaukee Air Pageant. He stood outside the fence seeing, what the EAA notes, was an "...organization [that] could claim more than 200 card-carrying members, and 700 people watching the show." Ron was not a registered guest but he soon became a welcome visitor. While standing at the fence, Ron was approached by a man who asked him if he was interested in airplanes. When he answered yes, Paul Poberezny invited him to "...come on in and take a look." Paul introduced Ron to Steve Wittman and even offered up a membership. "We can join you up now, if you want" however Ron politely declined, not having the requisite \$5.00. It wasn't until 1956 that he joined the EAA. His lifetime membership number is 4402.

Thus began a lifelong friendship with the man who helped found the Experimental Aircraft Association. Paul would regularly invite Ron to his house in Hales Corners, and Ron would ride his Cushman

motor scooter over, go down into Paul's basement and chat about airplanes. The basement was "Headquarters" and it was where Paul would talk to Ron about "grass roots aviation' and Paul's desire that the average man could get a plane into the air. The EAA museum in Oshkosh has a replica of Paul's garage workshop that is so true to life it gives Ron an eerie feeling of having been there before.....because he has. Ron recalls seeing Paul at one of the last fly-ins, before he passed, and Paul made sure to kid

The guys from the Headquarters Chapter in Hales Corners began to regularly meet in the Gran-Aire facility at Curtis Wright airport in a little room "by the candy machines" but soon moved upstairs near the Link Trainer. The meetings were comprised of a close knit group of 15 guys. The center of conversation was primarily the modifications of factory built airplanes. The most popular was the Cub. Ron remembers that the guys would "buy Cubs for \$400-\$500, cut down the back of it a little bit, clip the wings, and they make their own airplanes." Meetings were spent talking about how cheap they could build their airplanes. Members would often park their aircraft with a piece of paper visible that outlined the small cost undertaken to get it in the air. Ron remembers the modified Cubs with papers indicating a \$400 investment to modify the aircraft. Ron didn't get too involved in the administrivia of running the Chapter. The guys operated as the "Headquarters Chapter" as other chapters developed around the country including Chapter 1 in Flabob, California. It wasn't until nearly 1960 that guys thought, "we should've been Chapter 1" and then somehow got to be Chapter 18.

Ron didn't learn to fly immediately upon encountering the EAA. A friend at Curtis Wright field, who was an instructor, had a midair collision and perished. That dampened Ron's initial desire to fly. Ultimately, Ron ventured out to Rainbow Airport to plunk down \$10 for dual and \$7 for solo flights. In 1965 he began soaring for fun at Aero Park.

Life got in the way, and Ron stopped going for a bit of time. At that time in history, the United States still maintained a draft of young men into the Armed Forces. Paul, who was working with the Air National Guard, offered to help Ron join the Guard as a Ground Support Equipment Repairman. When Ron was working one day, Paul came by and asked "...how'd you like to go for an airplane ride?" "Be here on Wednesday morning at 8:00 and wear your uniform." Ron followed instructions and found himself on a C47 ferrying some newspaper reporters to Bunker Hill AFB in Indiana. Paul told Ron that he didn't have clearance to leave the aircraft at Bunker Hill so Ron waited for their return, watching other aircraft from inside the parked C47. Paul returned and let Ron know they were leaving the reporters at Bunker Hill and would be taking off right away for Mitchell Field. Paul let Ron stand between the pilot and copilot as the plane departed the runway. After being in the air for a short time, Paul said that they were going to fly to Hales Corners and "buzz the house" prior to landing at Mitchell. Paul turned to Ron and asked, "You have a private ticket, don't you?" Ron said yes. "Good", replied Paul as he unbuckled and got up. "You can take over." Ron felt good because the Co-Pilot was still in his seat. After about 15 minutes the Co-Pilot told him that he was going to get some coffee. Ron felt "on top of the world," all by himself in the cockpit of a C47. It seemed like forever before Paul came back and asked Ron, "How'd you do?" Ron's reply? "We're still in the air!!"

In his long aviation life, Ron has spent time in many airplanes. Early on he built a Flying Plank. The



Plank is a mid-wing, single seat, flying wing glider designed by Al Backstrom in 1954. In 2011 there were two registered in the United States, including one in the National Soaring Museum. It's unlikely that Ron's aircraft was one of them. He used electrical conduit for lift struts and bed sheets for covering, and only flew it three times

because "it scared me too much." He donated it to the EAA museum in Hales Corners and has not seen it since.

Ron often obtained unfinished projects and took them to completion. He finished an Evans VP-1 Volksplane and flew it to Oshkosh many times. The Volksplane is an allwood, strut-braced open-cockpit single-seat, low wing aircraft primarily designed to use a modified VW type 1 automotive engine from the VW Beetle.



Finally, Ron put himself in a RaceAir Skylite that he modified to fit him. The Skylite is an ultralight designed to to

resemble the high-wing air racers of the 1930s. Ron's aircraft adorns his EAA lifetime membership card.

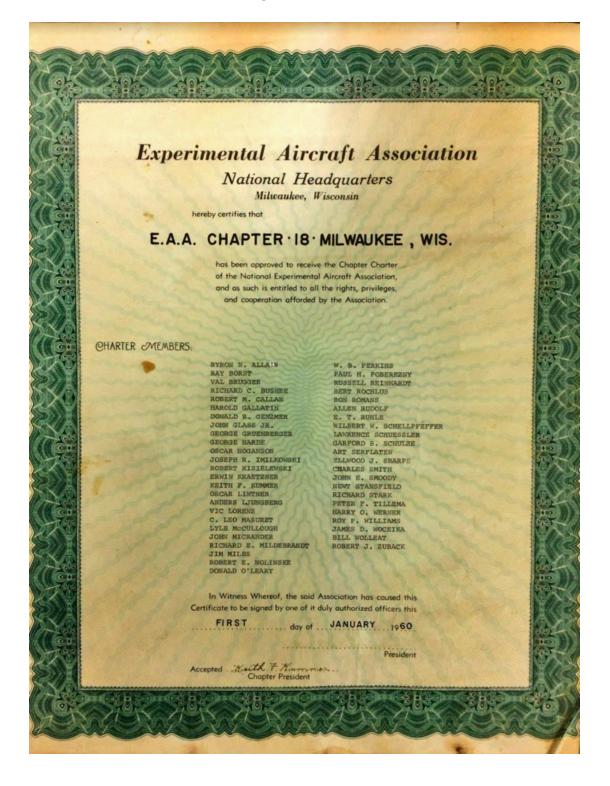
